Resource Advisory Council to Accept Project Proposals

Kernville, CA: The Kern and Tulare Counties Resource Advisory Committee (RAC) is seeking a new round of applications for funding natural resource projects. These projects would enhance forest ecosystems or restore and improve land health and water quality on the Sequoia National Forest and other nearby lands in Tulare and Kern Counties.

The RAC will have nearly \$70,000 to fund proposals in Tulare and Kern Counties this year. These funds are made available through the Secure Rural Schools and Community Self-Determination Act. Proposals will be accepted in hard copy, by email, or in person, with this round due September 6, 2012. Proposal application forms and instructions are available on the Sequoia National Forest at: www.fs.fed.us/r5/sequoia under "Kern and Tulare Counties RAC".

The RAC works closely with the Forest Service to recommend projects that will benefit forest health, fish, wildlife, soils, watersheds and other resources; maintain roads, trails, and other infrastructure; or control noxious weeds.

The RAC funded seventeen projects in Kern and Tulare Counties (2008-2011), totaling nearly \$400,000.

The public is welcome to attend the RAC meetings and observe the proceedings. If you plan to present your proposal in person at either meeting, please notify Penelope Shibley a week in advance by calling (760) 376-3781 ext 650. Presentations will be limited to 10 minutes per proposal.

Past projects that were funded included: trail maintenance in Camp Nelson, Golden Trout Wilderness, Pacific Crest Trail, Long Meadow, Forks of the Kern, Trail of 100 Giants and Domeland Wilderness areas; Riverside Park improvements; Buck Rock Fire lookout restoration; and Alta Sierra and Johnsondale fuels reductions projects. Partnerships have included the Tule River Tribe, High Sierra Volunteer Trail Crew, Kern River Valley Fire Safe Council, Buck Rock Foundation, Backcountry Horsemen, Kern County Fire, and Kern Valley River Association.
