John Cheek - Sworn Interview

Q: Do you know Flora?

A: No

Comment - Flordeliza "Flora" Suntup in this investigation is the same woman who cleans for the USACE sometimes, this would be known to Mr. Cheek since he is involved in setting up the cleaning personnel to fill in as needed. Suntup and Cheek would have discussed when she would have been needed to clean. Suntup would have even cleaned Cheek's office during a typical day of normal office operations. James Harris and Rebecca Zurschmiede (employees) with the Louisville District USACE may have insight on Suntup and Cheek's communications. I believe John Cheek was aware of who Flora Suntup is in relation to the investigation.

Q: Why do you believe this has been reported? A: Retaliation by Paul Jason Polly. Mr. Polly was terminated in February 2008 for falsifying a letter of recommendation by his Supervisor to obtain a USCG master license.

Comment - His answer goes against the settlement brokered by the MSPB between myself and the USACE. I "resigned" my position and that is to be the official statement by the USACE. John Cheek violated the settlement by stating I was terminated.

Gary Murphy - Sworn Interview

Mr. Murphy claims his primary residence is by Jeffersonville IN, and a secondary residence by Owensboro KY. These residences are the point of the TDY issues with Mr. Murphy.

Comment - I think Mr. Murphy has stated his residences incorrectly and needs corrected. I found the information below to determine primary residency.

Edward B. Jones, CPA - Kossler Jones & Company, LLC

SETTLEMENT AGREEMENT

Whereas, Paul J. Polly (hereinafter Polly) has appealed his removal from his position as derrick boat deckhand with the U.S. Army Corps of Engineers, Louisville District (hereinafter "Louisville District"), for cause under MSPB Docket No. CH-0752-08-0412-I-1;

Whereas Polly has challenged his non-selection for Derrick Boat Operator Trainee with the Louisville District under MSPB Docket No. CH-1221-08-0424-W-1; and

Whereas Polly, the Louisville District, and its parent agency the Department of Army (hereinafter "Army") desire to resolve their differences amicably and expeditiously,

NOW THEREFORE, the parties agree as follows:

- 1. The Army agrees to allow Polly to resign effective February 5, 2008.
- 2. The Army agrees to amend Polly's official personnel records to reflect a resignation, rather than a removal effective February 5, 2008.
- 3. The Army agrees to delete all mention of Polly's removal and the basis therefor from Polly's official personnel records.

- 4. Employment inquiries will be referred to the Louisville District's Civilian Personnel Advisory Center, who will limit its response to date, position, and length of employment.
- 5. Polly will withdraw with prejudice his appeals CH-0752-08-0412-I-1 and CH-1221-08-0424-W-1 as of the date of this agreement.
- Polly will not seek employment with the U.S. Army Corps of Engineers 6. subsequent to the date of this agreement.
- Polly will not raise the matters at issue in appeals CH-0752-08-0412-I-1 and 7. CH-1221-08-0424-W-1 in any future administrative or judicial proceeding, to include Merit Systems Protection Board proceedings, Equal Employment Opportunity complaints, union grievances, unfair labor practice charges, or any similar actions.

On November 7, 2008, Mr. Polly reported to the CID agent investigating the case that he (Mr. Polly) had received a voicemail from Mr. Harris pertaining to the investigation. [Tab H, Exhibit 11, Agent's Investigative Report of SA Number 2, page 1].Mr. Polly played the voicemail to a CID agent who transcribed it as follows:

Paul, what are you trying to do again? What did you report this for ... to the Army for? They are goin' after her. They ain't, they ain't talkin' to John Cheek, they're goin' after her. Poor little girl ain't had nothin'. Her momma died when she was fifteen. She never had a daddy. And now they're goin' after her. She's wiggin' out. I owe you one for this one, buddy, reporting on her bed and breakfast. You didn't accomplish nothin' but (incoherent words). I owe you one.

The Interview of Mr. Murphy

The CID agent charged with investigating the case interviewed Mr. Gary W. Murphy on August 28, 2008. Mr. Murphy waived his rights and gave a verbal statement in which he stated he had submitted travel vouchers claiming only mileage and Meals and Incidentals Expenses (M&IE) while residing at his "secondary" residence in Owensboro, Kentucky while TDY [Tab F, Agent's Investigative Report of SA Number 2, pages 1-2]. Mr. Murphy told the CID agent that he claims his Jeffersonville, Indiana home as his primary residence because his job is located in Louisville, Kentucky. 17 Mr. Murphy also has a secondary residence in Owensboro, Kentucky, which he stays at while working TDY in the Owensboro area. Mr. Murphy admitted to submitting travel vouchers claiming mileage and Meals & Incidental Expenses (M&IE) while staying at this secondary residence; however, Mr. Murphy did not state that he was also claiming lodging reimbursement while staying at this secondary residence. Mr. Murphy further stated that he had discussed this issue with his supervisor and the District's travel support personnel and was informed that he was authorized to claim mileage and M&IE because he was in an authorized TDY status and he was not staying at his primary residence in the Jeffersonville/Louisville area.

The Interview of Mr. Harris

CID interviewed Mr. James W. Harris on August 28, 2008. In his interview, Mr. Harris waived his rights and gave a sworn statement in which he stated he had been dating Ms. Flordeliza Suntup for approximately eight years and that he had started staying in her apartment at 514A Richardt Avenue, Evansville, Indiana approximately five or six years ago [Tab F, Exhibit 10, Sworn Statement of Mr. James W. Harris]¹⁸. Mr. Harris stated that when he stayed at Ms. Suntup's apartment, he
