SUBJECT: 22 August 2008 – Field Observations of the Industrial Hygiene Facility Assessment Process

1. A site visit was completed 22 August 2008 by Mr. Daniel D. Mitchell, a Certified Industrial Hygienist from my office, to provide technical review of the health hazard facility assessment process. Mr. Mitchell met with 1LT Derivan who provided contact information and guidance on the intent of the site visit. An assessment of building 77 was previously scheduled.

2. Mr. Mitchell then met with Mr. Karl Gibson, Industrial Hygiene Program Manager, and explained that the purpose of the visit was to observe the facility assessment process and provide technical observations. In addition, Mr. Mitchell, as a professional colleague, is available to provide unofficial review and feedback to Mr. Gibson on technical issues and documents related to the facility hazard assessment process.

3. Mr. Gibson provided copies of worksheets used to document observations and instrument readings. Building 77. Mr. Gibson identified the rooms within the building associated with each of the operations. Each room was then visited and real-time monitoring was performed. Real-time monitoring included respirable particulate, noise, light levels, temperature, relative humidity, carbon dioxide. Calibration records for each of the instruments were reviewed; however, Mr. Mitchell was not present during the calibration of each of the instruments. Mr. Gibson provided copies of previous inspection reports for building 77.

Observations:

a. Real-time monitoring techniques appeared to comply with accepted industrial hygiene practices.

b. However, the quantity of real-time sampling performed, routine nature, and sole reliance on sample results may not reflect DOD's intention for the annual facility inspections (surveys) (DA PAM 40-503 4-4.b). It is our understanding that the preliminary identification of hazards should rely considerably on professional judgment of qualified individuals (DODI 6055.5 6.1.1). There are no known requirements that specify the use of real-time instruments during facility inspections. However use of such instruments, as they are readily available, should be used at the discretion of the industrial hygienist to assist in determining hazard severity.

c. The format of the inspection report may not concisely communicate information that has been tailored to the needs of the facility director or operation commander.

d. A concern was expressed by the industrial hygienist that the reporting process may not provide adequate means for their professional opinion to be incorporated into the record.

5. Recommendations:


a. Review facility inspection process to identify means to simplify the process and place emphasis on the industrial hygienist's professional judgment. The process should incorporate qualitative aspects and observation skills and not rely solely on the use of real-time instruments.

b. Revise reporting requirements to tailor the report to the needs of the operation's commander and add a process by which technical data and the industrial hygienist's opinions can made for the record. Therefore, two separate documents are suggested. The first, a memorandum for record or industrial hygienie report for record that is used internal to Preventive Medicine to be signed by the industrial hygienist (AR 25-50 2-7). This document will provide adequate detail to demonstrate that standard industrial hygiene practices were followed. The document along with supporting documentation, such as calibration records, should be maintained for defense from an audit. This document would include industrial hygienist's recommendations. The second document, would concisely report findings pertinent to the operation. For annual assessments as a minimum we suggest addressing two items: 1) Confirm, based on professional opinion, whether the facility complies with occupational health standards (Army and OSHA standards); and 2) A list of identified hazards that are recommended for inclusion into the operation's risk management processes (DODI 6055.1 E3.6.3).

MAJ Nobach,

I am disappointed in the revised report. Again in the report, Karl is citing standards that are incorrect. For example for lighting on page 33, "BOLD is for locations that do not meet ACA standards. Even if the pod average complies, there must be 90% or greater of the cells tested meet the ACA Standards." I am an ACA auditor and just complete refresher training on 31 Jan 06 from the ACA Accreditation and Standards Division and this is a false statement. There is no 90% standard for ACA.

For the noise levels: How is it measured? An average from 2215 hours until 0500. At 0500 hours, the intercom in the common area of the pod announces "First Call" and all of the inmates door are electronically only opened "popped". How is that measured by the noise instrument. Did it spike at this time in all of the pods and drive the average up? If so, then the reading should only be read prior to "First Call". This would give a true reading. Once of the housing units had a night time dBA higher then the daytime dBA reading?

DIS and Karl had a meeting that I attended for a short time, but the agreement was that would revise Tab 1 of our IH Survey in the format he provided in 2003 for our ACA . He send examples via email and I responded with my input and he did what he wanted.

Thonestly believe that Karl had a vendetta against the USDB and goes out of his way to make us non-compliant in every function that he can manipulate. COL Harrison sent a memorandum in May 2005 prior to the IH survey through COL Davis to MAJ Nobach requesting that Karl provide the data for ACA and refrain from making conuments. He told me that he took this memorandum as we did not want him to use ACA standards for our ACA audit and that he would find harsher standards to measure us by. What logic is that? Would the MAHC not use JCAHO standards for their JCAHO standards.







After contacting the Fort Leavenworth Safety Director, Ms. Pam Bowser, who stated she has no record of the subject event, nor any such event, I contacted Ms. Jo Osborne, the Fort Leavenworth Civilian Personnel Advisory Center (CPAC) Director, to confirm that no Workers' Compensation claim had been filed. Ms. Osborne, who would certainly have a record of any incident in which a Fort Leavenworth worker was transported to a hospital by ambulance, similarly was not able to find any documentation of any such incident. I conclude form this information that the alleged incident, at least as described by Mr. Gibson, never occurred.
