Army Europe Regulations 600-17 and 600-700

- **Eligibility – The following personnel may obtain limited rationed fuel within Germany:**
 - **TDY: US Forces personnel who are in TDY status (with DD1610 or equivalent orders) when the individual is TDY within Germany**
 - **Leave or Military Pass: US Forces personnel (US military personnel and DOD civilians who are in sponsor status) who are stationed within Europe but outside of Germany or in North Africa when the sponsor is on leave or on military pass within Germany.**
- **Basis for eligibility:**
 - **TDY eligibility is based on the original US/Germany NATO Status of Forces Agreement and Supplementary Agreement**
 - **Annual leave and military pass eligibility is based on US/Germany Agreement on the Status of Personnel on Leave**

Procedures – From outside of Germany

• Process:

- Bring TDY (DD Form 1610), leave (OPM Form 71), or Pass (DA Form 31)
- Get short-term eligibility certificate (AE Form 550-175L) from:
 - IMCOM Europe garrison MP Stations →
 - US Forces Customs Offices → **(slide 4)**
- Get short-term fuel ration card from any of the AAFES sites **(slide 6)**
- Add pre-paid cash value before pumping fuel at Esso in Germany
- Leave unused pre-paid cash in account for use with next short-term card
- Or, request refund of unused pre-paid cash after the card expires by:
 - Calling the toll-free phone number within Germany or
 - Emailing the refund request to “yyEUEssoFuelCard@aafes.com”

• Important

- Get eligibility certificate, activate fuel ration card, and add pre-paid cash value before pumping fuel
- Never pump more fuel than the existing ration balance covers
