

## **GERMANY FUEL RATION CARD – VIDEO TRAINING MODULE 3**

### **REQUESTING, RECEIVING, & ACTIVATING SHORT-TERM FUEL RATION CARDS FOR ALL VEHICLES THAT ARE NOT REGISTERED IN USAREUR**

US FORCES PERSONNEL WHO ARE PERMANENTLY STATIONED IN GERMANY OR ON TDY, ANNUAL LEAVE, OR MILITARY PASS IN GERMANY MAY ESTABLISH ELIGIBILITY FOR PRIVATELY OWNED VEHICLES THAT ARE NOT REGISTERED IN USAREUR AND FOR RENTAL VEHICLES. THE INDIVIDUAL WILL GO TO ANY IMCOM EUROPE GARRISON MILITARY POLICE STATION OR TO THE US FORCES CUSTOMS OFFICE AT THE RAMSTEIN INN GUESTHOUSE OR HOTEL ON RAMSTEIN AIR BASE, IN BUILDING 316 ON SPANGDAHLEM AIR BASE, OR AT THE 470<sup>th</sup> AIR BASE SQUADRON MILITARY CUSTOMS OFFICE AT THE NATO AIR BASE IN GEILENKIRCHEN, GERMANY.

THE INDIVIDUAL WILL PROVIDE A COPY OF THEIR STATIONING ORDERS, TDY, LEAVE, OR MILITARY PASS DOCUMENT ALONG WITH A COPY OF THEIR PRIVATELY OWNED VEHICLE REGISTRATION OR RENTAL CONTRACT.

THE MILITARY POLICE OR US FORCES CUSTOMS OFFICE WILL ISSUE THE DRIVER A SHORT-TERM ELIGIBILITY CERTIFICATE, WHICH WILL NOT EXCEED THIRTY DAYS.

THE INDIVIDUAL WILL TAKE THE CERTIFICATE TO THE NEAREST AAFES CARD ISSUE AND ACTIVATION SITE. PLEASE REFER TO THE “RECEIVING & ACTIVATING NEW VEHICLE FUEL RATION CARDS” TRAINING MODULE 3 FOR CARD CREATION AND ACTIVATION PROCEDURES.

SHORT-TERM FUEL RATION CARDS WILL HAVE AN EXPIRATION DATE PRINTED ON THE BACK OF THE CARD, ALONG WITH THE PLATE NUMBER OF THE ELIGIBLE VEHICLE FOR NO MORE THAN TWO ELIGIBLE DRIVER NAMES.

NOTE: THE SHORT-TERM ELIGIBILITY CERTIFICATE REPLACES THE REGISTRATION CERTIFICATE IN THE CARD ISSUE PROCESS.
