1. **Authority**

The Coordinating Committee was established by resolution of the National Capital Planning Commission adopted August 8, 1952, pursuant to authority for the creation of the Committee contained in Section 2(d) of the National Capital Planning Act of 1952.

2. **Functions**

The function of the Coordinating Committee is to ensure the maximum amount of coordination and cooperation among the various agencies of the Federal and District of Columbia Governments in order that the National Capital may be developed in accordance with the Comprehensive Plan. The Coordinating Committee will review projects located in the District of Columbia. While the Coordinating Committee may evaluate various aspects of a proposed project, their recommendations to the Commission will only address inter-agency coordination. Other issues discussed may be included in the National Capital Planning Commission Executive Director's Recommendation to the Commission where appropriate. Projects that will be coordinated by this committee include the following:

- a. Amendments to the Permanent System of Highways Plan; ¹
- b. Closing of streets and alleys under the Street Readjustment Act of the District of Columbia;²
- c. Location, height, bulk, number of stories, and size of, and the provision for open space in and around, Federal buildings in the District of Columbia;³
- d. General location, boundary lines, and site development and subdivision plans of public housing projects;⁴
- e. General location, boundary lines, and plans for urban renewal projects; ⁵
- f. Public off-street parking facilities;⁶
- g. Transfer of jurisdiction over property among or between Federal and District of Columbia agencies;⁷
- h. Sale of land no longer required for public purposes by the District of Columbia⁸ or the National Park Service⁹:
- Planning, use, improvement, and development of the Recreation
 System of the District of Columbia; and
- j. Land acquisition programs of agencies of the Federal and District of Columbia Governments within the District of Columbia. 10
- k. Alterations, revisions or amendment of the Adopted Regional

 System of the Washington Metropolitan Area Transit Authority. 11

3. <u>Membership</u> 12

4. <u>Officers</u>

- a. <u>Chairman</u> The Executive Director, National Capital Planning Commission, or his ¹³ designated alternate, shall serve as Chairman of the Committee and preside at Committee meetings.
- b. <u>Secretary</u> The Executive Director of the National Capital Planning
 Commission shall designate a member of the staff of the Commission
 to serve as Secretary to the Committee.
- c. <u>Counsel</u> The General Counsel of the National Capital Planning
 Commission shall serve as Counsel to the Committee.

5. Meetings

- a. <u>Time and Place</u> The monthly meeting dates and time for this committee will be determined on an annual basis and distributed to all members. The meetings will be in the offices of the National Capital Planning Commission Washington D.C., unless otherwise determined by the Chairman.
- b. Quorum A simple majority of the regular members and, in the absence of members, their designated alternates shall constitute a quorum. A quorum will be required to officially forward comments of the Coordinating Committee to the Commission.
