# **A BILL**

To direct the Secretary of the Interior to establish goals for an all-of-the-above energy production plan strategy on a 4-year basis on all onshore Federal lands managed by the Department of the Interior and the Forest Service.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Planning for American*  
5 *Energy Act of 2012”.*

6 **SEC. 2. ONSHORE DOMESTIC ENERGY PRODUCTION STRA-**  
7 **TEGIC PLAN.**

8 *(a) IN GENERAL.—The Mineral Leasing Act (30*  
9 *U.S.C. 181 et seq.) is amended by redesignating section 44*  
10 *as section 45, and by inserting after section 43 the fol-*  
11 *lowing:*

12 **“SEC. 44. QUADRENNIAL STRATEGIC FEDERAL ONSHORE**  
13 **ENERGY PRODUCTION STRATEGY.**

14 *“(a) IN GENERAL.—*

15 *“(1) The Secretary of the Interior (hereafter in*  
16 *this section referred to as ‘Secretary’), in consultation*  
17 *with the Secretary of Agriculture with regard to lands*  
18 *administered by the Forest Service, shall develop and*  
19 *publish every 4 years a Quadrennial Federal Onshore*  
20 *Energy Production Strategy. This Strategy shall di-*  
21 *rect Federal land energy development and department*  
22 *resource allocation in order to promote the energy se-*  
23 *curity of the United States.*

24 *“(2) In developing this Strategy, the Secretary*  
25 *shall consult with the Administrator of the Energy*

1 *Information Administration on the projected energy*  
2 *demands of the United States for the next 30-year pe-*  
3 *riod, and how energy derived from Federal onshore*  
4 *lands can put the United States on a trajectory to*  
5 *meet that demand during the next 4-year period. The*  
6 *Secretary shall consider how Federal lands will con-*  
7 *tribute to ensuring national energy security, with a*  
8 *goal for increasing energy independence and produc-*  
9 *tion, during the next 4-year period.*

10 *“(3) The Secretary shall determine a domestic*  
11 *strategic production objective for the development of*  
12 *energy resources from Federal onshore lands. Such ob-*  
13 *jective shall be—*

14 *“(A) the best estimate, based upon commer-*  
15 *cial and scientific data, of the expected increase*  
16 *in domestic production of oil and natural gas*  
17 *from the Federal onshore mineral estate, with a*  
18 *focus on lands held by the Bureau of Land Man-*  
19 *agement and the Forest Service;*

20 *“(B) the best estimate, based upon commer-*  
21 *cial and scientific data, of the expected increase*  
22 *in domestic coal production from Federal lands;*

23 *“(C) the best estimate, based upon commer-*  
24 *cial and scientific data, of the expected increase*  
25 *in domestic production of strategic and critical*

1           *energy minerals from the Federal onshore min-*  
2           *eral estate;*

3           “(D) *the best estimate, based upon commer-*  
4           *cial and scientific data, of the expected increase*  
5           *in megawatts for electricity production from*  
6           *each of the following sources: wind, solar, bio-*  
7           *mass, hydropower, and geothermal energy pro-*  
8           *duced on Federal lands administered by the Bu-*  
9           *reau of Land Management and the Forest Serv-*  
10          *ice;*

11          “(E) *the best estimate, based upon commer-*  
12          *cial and scientific data, of the expected increase*  
13          *in unconventional energy production, such as oil*  
14          *shale; and*

15          “(F) *the best estimate, based upon commer-*  
16          *cial and scientific data, of the expected increase*  
17          *in domestic production of oil, natural gas, coal,*  
18          *and other renewable sources from tribal lands for*  
19          *any federally recognized Indian tribe that elects*  
20          *to participate in facilitating energy production*  
21          *on its lands.*

22          “(4) *The Secretary shall consult with the Admin-*  
23          *istrator of the Energy Information Administration*  
24          *regarding the methodology used to arrive at its esti-*  
25          *mates for purposes of this section.*

1           “(5) *The Secretary has the authority to expand*  
2           *the energy development plan to include other energy*  
3           *production technology sources or advancements in en-*  
4           *ergy on Federal lands.*

5           “(b) *TRIBAL OBJECTIVES.—It is the sense of Congress*  
6           *that federally recognized Indian tribes may elect to set their*  
7           *own production objectives as part of the Strategy under this*  
8           *section. The Secretary shall work in cooperation with any*  
9           *federally recognized Indian tribe that elects to participate*  
10           *in achieving its own strategic energy objectives designated*  
11           *under this subsection.*

12           “(c) *EXECUTION OF THE STRATEGY.—The relevant*  
13           *Secretary shall have all necessary authority to make deter-*  
14           *minations regarding which additional lands will be made*  
15           *available in order to meet the production objectives estab-*  
16           *lished by strategies under this section. The Secretary shall*  
17           *also take all necessary actions to achieve these production*  
18           *objectives unless the President determines that it is not in*  
19           *the national security and economic interests of the United*  
20           *States to increase Federal domestic energy production and*  
21           *to further decrease dependence upon foreign sources of en-*  
22           *ergy. In administering this section, the relevant Secretary*  
23           *shall only consider leasing Federal lands available for leas-*  
24           *ing at the time the lease sale occurs.*

1       “(d) *STATE, FEDERALLY RECOGNIZED INDIAN*  
2 *TRIBES, LOCAL GOVERNMENT, AND PUBLIC INPUT.*—*In de-*  
3 *veloping each strategy, the Secretary shall solicit the input*  
4 *of affected States, federally recognized Indian tribes, local*  
5 *governments, and the public.*

6       “(e) *REPORTING.*—*The Secretary shall report annu-*  
7 *ally to the Committee on Natural Resources of the House*  
8 *of Representatives and the Committee on Energy and Nat-*  
9 *ural Resources of the Senate on the progress of meeting the*  
10 *production goals set forth in the strategy. The Secretary*  
11 *shall identify in the report projections for production and*  
12 *capacity installations and any problems with leasing, per-*  
13 *mitting, siting, or production that will prevent meeting the*  
14 *goal. In addition, the Secretary shall make suggestions to*  
15 *help meet any shortfalls in meeting the production goals.*

16       “(f) *PROGRAMMATIC ENVIRONMENTAL IMPACT STATE-*  
17 *MENT.*—*Not later than 12 months after the date of enact-*  
18 *ment of this section, in accordance with section 102(2)(C)*  
19 *of the National Environmental Policy Act of 1969 (42*  
20 *U.S.C. 4332(2)(C)), the Secretary shall complete a pro-*  
21 *grammatic environmental impact statement. This pro-*  
22 *grammatic environmental impact statement will be deemed*  
23 *sufficient to comply with all requirements under that Act*  
24 *for all necessary resource management and land use plans*  
25 *associated with the implementation of the strategy.*

1           “(g) *CONGRESSIONAL REVIEW.*—At least 60 days prior  
2 to publishing a proposed strategy under this section, the  
3 Secretary shall submit it to the President and the Congress,  
4 together with any comments received from States, federally  
5 recognized Indian tribes, and local governments. Such sub-  
6 mission shall indicate why any specific recommendation of  
7 a State, federally recognized Indian tribe, or local govern-  
8 ment was not accepted.”.

9           (b) *FIRST QUADRENNIAL STRATEGY.*—Not later than  
10 18 months after the date of enactment of this Act, the Sec-  
11 retary of the Interior shall submit to Congress the first  
12 Quadrennial Federal Onshore Energy Production Strategy  
13 under the amendment made by subsection (a).

14 **SEC. 3. DEFINITIONS.**

15           For purposes of this Act, the term “strategic and crit-  
16 ical energy minerals” means those that are necessary for  
17 the Nation’s energy infrastructure including pipelines, re-  
18 fining capacity, electrical power generation and trans-  
19 mission, and renewable energy production and those that  
20 are necessary to support domestic manufacturing, including  
21 but not limited to, materials used in energy generation, pro-  
22 duction, and transportation.
