

## OSC TRANSMITS DEPARTMENT OF DEFENSE REPORT CONFIRMING MISUSE OF AGENCY FUNDS

WASHINGTON, DC/September 29, 2010 – Today, the U.S. Office of Special Counsel (OSC) transmitted to the President and Congress the Department of Defense's (DOD) response to whistleblower allegations that DOD employees were improperly using the fees collected for Information Analysis Center (IAC) programs for DOD functions and activities that are unrelated to the IAC programs. The whistleblower, Russ Daul, the former Director of the Resource Management Directorate at DOD, also disclosed that employees failed to report the IAC monies and implemented faulty policies to justify their misuse of the funds.

The reports from DOD to OSC found that employees violated the Economy Act, 31 U.S.C. § 1535, and inappropriately augmented DOD's budget. DOD improperly charged indirect costs for the goods and services it provided to federal agencies and other customers in fiscal years (FYs) 2007 and 2008. DOD collected fees in excess of its actual costs and did not return the surpluses to its customers. As a result, DOD overcharged its customers by \$12.1 million in FY 2007 and \$9.7 million in FY 2008. The investigation partially substantiated that DOD failed to report the IAC monies. The investigation also determined that the then-Administrator managing the IAC program was aware of and assented to the continued practice of improperly accounting for the IAC fees, did not take action to correct the IAC fee policy problems when notified, and that such actions constituted gross mismanagement.

In response to the investigative findings, DOD established an IAC Reimbursable Review Board (Review Board). Among other functions, the Review Board will create a fixed reimbursable rate, establish a plan for determining and returning surplus fees, and coordinate a review of budgeting method models. DOD will update its Financial Management Regulations to reflect the policy changes, and will conduct a study in FY 2011 to ensure that DOD complies with its reporting requirements. The Administrator was removed from his supervisory position and will not return. OSC determined that the agency's reports contain all of the information required by statute and that the findings appear reasonable.
