The program includes the entire family as well as couples and is customized to suit the specific needs of each family. **FOCUS** is offered in several formats; consultations, family and couples level training, small group training, and workshops. This highly confidential program is based on 20 years of research. **FOCUS** builds strong connections with other military and civilian family providers to support a network of care for military families. Founded in 1904, the **Navy-Marine Corps Relief Society** is a private, non-profit charitable organization, funded entirely by donations, that serves active duty and retired Navy and Marine Corps service members, their eligible family members and survivors. The mission of the Navy-Marine Corps Relief Society is to provide, in partnership with the Navy and Marine Corps, financial, educational, and other assistance to members of the Naval Services of the United States, eligible family members, and survivors when in need; and to receive and manage funds to administer these programs.

The Navy-Marine Corps Relief Society assists with emergencies through interest free loans or grants for the following needs:

- ➤ Food, Rent, and Utilities
- ➤ Medical/Dental Co-pays
- Personal and Large Scale Disasters
- > Essential Vehicle Repairs

# JUDGE ADVOCATE GENERAL (JAG)

There are two legal offices on the installation. The Navy Legal Service Office (NLSO) located in Building 30 (FFSC) provides services such as notaries, powers of attorney, wills and estate planning as well as other basic legal services. Additionally, they provide attorney advice on a wide range of legal topics such as separation and divorce, landlord tenant disputes and contract. The NLSO attorney's cannot represent you in civilian court but are ready, willing and able to provide practical advice and help you understand your legal issues and questions. Lastly, the NLSO attorneys serve as defense counsel for the purpose of courts-martial and administrative separation boards. They provide pre and post mast defense advice.

The Region Legal Service Office is located in Building 1, the CBC Headquarters Building. The Staff Judge Advocate for the installation serves as an advisor to Commanding Officers and Commodores. While they do not perform legal assistance, they are available to help guide you and your family in legal emergencies or conflicts with the NLSO. Additionally, they are the point of contact for complaints and questions you may have about federal, local and state laws.
