TREASURY TO AUCTION \$10,000 MILLION OF 2-YEAR NOTES

The Treasury will auction \$10,000 million of 2-year notes to refund \$25,494 million of publicly held securities maturing May 31, 2000, and to pay down about \$15,494 million.

In addition to the public holdings, Federal Reserve Banks hold \$3,838 million of the maturing securities for their own accounts, which may be refunded by issuing an additional amount of the new security.

The maturing securities held by the public include \$4,672 million held by Federal Reserve Banks as agents for foreign and international monetary authorities. Amounts bid for these accounts by Federal Reserve Banks will be added to the offering.

TreasuryDirect customers requested that we reinvest their maturing holdings of approximately \$652 million into the 2-year note.

The auction will be conducted in the single-price auction format. All competitive and noncompetitive awards will be at the highest yield of accepted competitive tenders.

The notes being offered today are eligible for the STRIPS program.

This offering of Treasury securities is governed by the terms and conditions set forth in the Uniform Offering Circular for the Sale and Issue of Marketable Book-Entry Treasury Bills, Notes, and Bonds (31 CFR Part 356, as amended).

Details about the new security are given in the attached offering highlights.

If the auction of 2-year notes to be held Wednesday, May 24, 2000, results in a yield in a range of 6.500 percent through and including 6.624 percent, the 2-year notes will be considered an additional issue of the outstanding 6-1/2% 5-year notes of Series G-2002 (CUSIP No. 9128272W1) originally issued June 2, 1997. The additional issue of the notes would have the same CUSIP number as the outstanding notes, which are currently outstanding in the amount of \$13,504 million.

If the auction results in the issuance of an additional amount of the Series G-2002 notes rather than a new 2-year note, it will be noted in the Treasury auction results press release. In the event of a reopening, all amounts outstanding for CUSIP No. 9128272W1, including the 5-year notes issued June 2, 1997, would be eligible for the STRIPS program.
