Benefits offered by AMH

NOTE: If the individual has an accepted workers' compensation claim, benefits must be processed through Penser.

- Schedules a National Jewish visit for additional testing
- Pays for National Jewish medical costs if there is not an accepted L&I or DOL claim
- Facilitates a retest every 1-3 years at National Jewish
- Does not cover medical other than approved medical provider

Benefits offered by DOE Hanford facility management contractor and it's teaming partners for diagnostic referrals

- Current Hanford workers only
 - · Paid regular wages
 - · Associated travel
 - Per diem
 - Companion travel (if determined to be necessary)
- Companion Associated Travel
 - Per diem
 - Wage loss if current Hanford employee of a prime or teaming sub

Once Chronic Beryllium Disease (CBD) is certified by a Physician

- Medical surveillance at AMH continues for current Hanford workers
- Continued screening at National Jewish is not paid through the AMH contract
- Treatment for accepted DOL/EEOICPA*and Washington State Labor & Industries workers' compensation claims will be paid through the appropriate agency

Washington State Labor & Industries (L&I) Workers' Compensation

The L&I laws allow you to file a workers' compensation claim at any time however, injuries must be reported within one (1) year of the date of accident.

Occupational diseases must be reported within two (2) years after receiving written notice from a doctor that the condition exists and is work related.

To file for compensation and medical under DOE's Self-Insurance worker's Compensation

- Must have employment history with a contractor covered by DOE's Self-Insurance (if not can file directly with L&I)
- File claim with PENSER or contact current benefits office if current employee
- Widow/widower can file a claim
- AMH diagnostic testing can be used as supporting medical with a physicians proof of sensitization
