B. Based on negotiations of WCH-REA-147, the following increases are hereby made to Contract Target Cost and Target Fee within Contract Line Item No. 1:

C. This modification is subject to adjustment pending resolution of internal and external reviews of the Contractor’s proposed Disclosure Statement Revision 7 and indirect cost rates. At the time of Contract definitization, internal and external reviews have not been completed. Therefore, the parties agree that the negotiated cost and fee above is subject to adjustment based on the results of subsequent reviews and resolution of review findings.
