



## MEMORANDUM OF UNDERSTANDING BETWEEN BECKER PROFESSIONAL REVIEW AND DEFENSE ACQUISITION UNIVERSITY

We, the undersigned, hereby agree to and affirm the establishment of a strategic partnership between Becker Professional Review, a division of DeVry, Inc., and the Defense Acquisition University (DAU) to offer certificate programs and other educational courses to the Department of Defense (DoD) military and civilian workforce.

As this strategic partnership evolves and includes additional programs, the Memorandum of Understanding (MOU) will be updated and reissued accordingly. Additions will be reflected as addenda to the basic MOU.

## Under this agreement Becker will:

- Provide DAU with a description of Becker programs to be offered.
- Provide Becker and GSA approved logos to be placed on the DAU website.
- Provide Becker program brochures to DAU for distribution.
- Provide quality education programs to support DoD personnel in the accounting, finance and project management field.
- Host a landing page to be linked from the DAU site that will link to select Becker web pages.
- Provide advice and assistance to students who want to enroll in Becker programs covered by this MOU.
- Award certifications of completion to students who complete Becker courses.

## Under this agreement, DAU will:

- Post an announcement of the DAU and Becker Strategic Partnership on the DAU website.
- List Becker as a Strategic Partner on the applicable DAU web page.
- Include a logo and description to Becker programs on the Strategic Partner's expansion page with links to the Becker landing page.

Both parties to this agreement intend to conduct the Becker - DAU strategic partnership on a continuing basis and to hold periodic reviews to ensure that the partnership is meeting the mutual needs of both institutions.

Students or their respective Federal Agency bear the responsibility for payment of tuition, fees, and any other costs related to enrollment in Becker programs.

Students will be subject to the policies and procedures of Becker Professional Review. Either party reserves the right to terminate, without liability, the strategic partnership when the interest of that party so dictates. Every effort will be made by either party to give 60-days notice prior to the effective date of termination and to complete the then current program year.

Becker or DAU may use the other party's name or logo in published materials (e.g., website and catalog) to reference this agreement or contact information/links to the others party. Content and text of all promotional information must be approved by each party prior to release.

No agreements concerning the transfer or exchange of any asset of either party is intended or implied by this memorandum. Becker Professional Review and DAU are separate and independent institutions of higher education and by this agreement both will continue to operate as separate institutions.

As this partnership evolves and specific new opportunities for additional collaboration are identified, this agreement may be revised as appropriate through the use of addendums.
