## **CUBA – UNITED STATES**

## Maritime Boundary Agreement Between the United States of America and the Republic of Cuba

This agreement was signed December 16, 1977 and, in accordance with Article V, the Parties agreed to "apply the terms of this Agreement provisionally from January 1, 1978, for a period of two years...." Every two years since then the two Governments have exchanged diplomatic notes to continue provisional application, as follows:
