INVESTMENT COMPANY ACT RELEASES

BILL GROSS' IDEALAB!

An order has been issued under Section 3(b)(2) of the Investment Company Act granting Bill Gross' idealab! (idealab!) a temporary exemption from all provisions of the Act. Idealab! filed an application on January 28, 2000 for an order under Section 3(b)(2) declaring that it is not an investment company. The temporary order extends the sixty day automatic exemption provided by Section 3(b)(2) upon the filing of an application in good faith. The temporary order will expire 120 days from the date of its issuance. Prior to the issuance of a permanent order to idealab!, if any, the Commission will issue a notice giving interested persons an opportunity to request a hearing. (Rel. IC -24369 - March 28)

HOLDING COMPANY ACT RELEASES

YANKEE ATOMIC ELECTRIC COMPANY

An order has been issued authorizing Yankee Atomic Electric Company, a subsidiary of National Grid USA (formerly New England Electric System) and Northeast Utilities, both registered holding companies, to repurchase from its stockholders 95% of its presently outstanding common stock, at a purchase price of \$100 per share, equal to the book value per share on June 30, 1999.
