ADMINISTRATIVE PROCEEDINGS

PROCEEDINGS INSTITUTED AGAINST EDWIN FISHBAINE

The Commission ordered public administrative proceedings under the Investment Advisers Act of 1940 against Edwin Fishbaine, a registered investment adviser and the publisher of The Terex Report. The Terex Report is a newsletter which analyzes and gives investment advice concerning the securities of companies, primarily mining and exploration companies listed on various Canadian stock exchanges.

The Order alleges that Fishbaine violated the antifraud provisions of the Advisers Act, the Securities Act of 1933, and the Securities Exchange Act of 1934 by failing to disclose to the readers of the Terex Report that Fishbaine was paid by various companies to publish and distribute favorable recommendations to purchase their securities in regular and special issues of the Terex Report. The Order further alleges that Fishbaine received "consulting fees," cash, stock, and stock options from companies whose securities he recommended to investors.

A hearing will be scheduled to determine whether the allegations are true, and if so, whether Fishbaine's registration as an investment adviser should be revoked and whether he should be barred from association with any investment adviser under Section 203(f) of the Advisers Act. (Rel. 33-6760)

EDWARD MICHAEL FURLONG BARRED

Administrative Law Judge David J. Markun issued an initial decision barring Edward Michael Furlong from association with a broker or dealer.

The bar is based upon findings that Furlong was convicted in October 1986 in the U.S. District Court for the Central Division of California upon his plea of guilty to a charge of securities fraud in violation of Section 10(b) of the Securities Exchange Act of 1934, 15 USC §78j(b), based upon his participation in a scheme to fraudulently manipulate the price of the common stock of Abex, Ltd., in 1983 and 1984.

The initial decision is subject to review by the Commission on its own motion or on petition of a party.

INVESTMENT COMPANY ACT RELEASES

CHARLES D. ADAMS

An order has been issued granting Charles D. Adams a limited exemption from the provisions of Section 9(a) of the Investment Company Act, applicable to him by virtue of an injunction entered in SEC v. LSL Corporation, No. S-73-CA-71, EDTX, December 7, 1973. (Rel. IC-16313 - March 14)

COMMAND GOVERNMENT FUND

An order has been issued permitting certain Prudential-Bache Funds to file with the Commission financial statements signed or certified by an independent accountant selected at a board of directors meeting held more than 30 days before or after the beginning of their fiscal years. FOUNDERS MUTUAL FUND

An order has been issued on five separate applications filed by Founders Mutual Fund, Founders Growth Fund, Inc., Founders Equity Income Fund, Inc., Founders Money Market Fund, Inc., and Founders Frontier Fund, Inc. declaring that they have ceased to be investment companies.
