## COMMISSION ANNOUNCEMENTS

### ORDER DENYING/SUSTAINING APPEAL

The General Counsel sent a letter to Donald Sheldon affirming in part and reversing in part the Freedom of Information Act Officer's decision to withhold access to a minute of a September 19, 1985 Commission meeting pertaining to Investment Management Portfolio, Inc. (IPM). The General Counsel determined that FOIA Exemption 5 properly applied to withhold those portions of the minute which reflect the give and take of the deliberative process. The General Counsel determined, however, to release the remainder of the minute since it contained purely factual matters and a final Commission decision. (Rel. FOIA-95)

## SELF-REGULATORY ORGANIZATIONS

### EFFECTIVENESS OF PROPOSED RULE CHANGE

The Pacific Stock Exchange filed a proposed rule change which became immediately effective upon filing under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposal (SR-PSE-88-20) will delete four options charges previously approved by the Exchange and submitted to the Commission in two prior filings: the Market Maker Fee; the Market Maker Give-up Charge; the Stock Execution Fee; and the Independent Broker Fee. The proposal will also reinstate these charges for 60 days from the date of this filing [August 19, 1988]. (Rel. 34-26073)

### NOTICE OF PROPOSED RULE CHANGE

The Pacific Stock Exchange filed a proposed rule change under Rule 19b-4 (SR-PSE-88-21) that would permanently approve four options fees: the Market Maker Fee; the Market Maker Give-up Charge; the Stock Execution Fee; and the Independent Broker Fee. These four fees were originally adopted by the PSE and submitted to the Commission in rule filings SR-PSE-88-11 and SR-PSE-88-16. The fees were subsequently deleted by the PSE and reinstated for 60 days in filing SR-PSE-88-20. Publication of the proposal is expected to be made in the Federal Register during the week of September 12. (Rel. 34-26074)

## TRUST INDENTURE ACT RELEASES

---

### AMERICAN AIRLINES, INC.

A notice has been issued giving interested persons until October 7 to request a hearing on an application by American Airlines, Inc., a Delaware corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. The application declares that the trusteeship of The Connecticut National Bank (a) in a single transaction under certain indentures that are not subject to qualification under the Act and two or more indentures to be qualified under the Act, and (b) under one or more of such qualified indentures and under certain other indentures not subject to the qualification under the Act, is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify the Bank from acting as trustee under any of such indentures. All of the indentures relate to leveraged lease transactions involving a lease of aircraft to the Company. (Rel. TI-2184)

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
