## ADMINISTRATIVE PROCEEDINGS

---

### PROCEEDINGS INSTITUTED AGAINST EFFICIENT TRANSFER, INC. AND ROGER G. COLEMAN, SR.

The Commission instituted administrative proceedings against Efficient Transfer, Inc., a registered transfer agent, and its principal owner and operator, Roger G. Coleman, Sr., of Salt Lake City, Utah.

The Order Instituting Proceedings alleges that Coleman, and Coleman doing business as Efficient, wilfully violated the antifraud and transfer agent provisions of the Securities Exchange Act of 1934 by falsifying certain shareholder records and failing to comply with record retention and examination requirements. The Order also alleges that Efficient, and Coleman doing business as Efficient, wilfully violated the Exchange Act by failing to maintain required books and records, failing to fingerprint employees, failing to safeguard securities, and failing to report lost and stolen certificates. The Order further alleges that Efficient and Coleman were permanently enjoined from further violations of these Exchange Act provisions on May 24 [SEC v. Efficient Transfer, Inc. and Roger G. Coleman, Sr., USDC UT, Civil Action No. 88-C-271W].

A hearing will be scheduled to take evidence on the staff's allegations and to afford Efficient and Coleman an opportunity to present any defenses. (Rel. 34-26208)

## INVESTMENT COMPANY ACT RELEASES

### THE PIERPONT MONEY MARKET FUND

An order has been issued on an application filed by certain mutual funds within the Pierpont Mutual Fund Group permitting them to file with the Commission financial statements signed or certified by an independent public accountant selected at a Board of Trustees meeting held more than thirty but not more than ninety days before or after the beginning of their respective fiscal years. ### ML OKLAHOMA VENTURE PARTNERS, LIMITED PARTNERSHIP

A notice has been issued giving interested persons until November 21 to request a hearing on an application filed by ML Oklahoma Venture Partners, Limited Partnership (the Partnership), ML OK Co., Limited Partnership (the Managing General Partner), and Merrill Lynch Venture Capital Inc. (the Management Company) (collectively, Applicants) for an order determining that: (1) the Independent General Partners (as hereinafter defined) of the Partnership are not "interested persons" of the Partnership, the Managing General Partner, or the Management Company by reason of being general partners of the Partnership and co-partners of the Managing General Partner; and (b) persons who become limited partners (the Limited Partners) of the Partnership who own less than 5% of the limited partnership interests in the Partnership will not be "affiliated persons" of the Partnership or any of its other partners solely by reason of their status as Limited Partners. EASTERN UTILITIES ASSOCIATES; ENERGY INITIATIVES, INCORPORATED;  
THE COLUMBIA GAS SYSTEM, INC.

(CVA), whereby Columbia will transfer all of the common shares of CVA, \$25 par value, to COS in exchange for COS's common stock, \$50 par value, on a two-for-one basis to effect a merger of CVA into COS.

## SELF-REGULATORY ORGANIZATIONS

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGES

The Commission granted accelerated approval to a proposed rule change filed by: The Midwest Stock Exchange (SR-MSE-88-9) to implement coordinated circuit breaker procedures during volatile market conditions. The MSE's proposal provides for a one-hour halt in the trading of stocks if the Dow Jones Industrial Average (DJIA) declines 250 points from its previous day's close; a second two-hour closing will occur if the DJIA falls 400 points. (Rel. 34-26218); and The American Stock Exchange (SR-Amex-88-25) that expands to 16 the number of component stocks in its Oil Index. (Rel. 34-26222)

## TRUST INDENTURE ACT RELEASES

### PIEDMONT AVIATION, INC.

A notice has been issued giving interested persons until November 21 to request a hearing on an application by Piedmont Aviation, Inc., a North Carolina corporation, under Section 310(b)(1)(ii) of the Trust Indenture Act of 1939. 1988 Equipment Trust Certificates, Series J and K, and two dated October 15, 1988 relating to \$44.8 million of 1988 Equipment Trust Certificates, Series H and I, each of which have been submitted for qualification under the Act, and four dated September 15, 1988 relating to \$89.6 million of Equipment Trust Certificates, and three dated March 1, 1988 relating to approximately \$58.9 million of Equipment Trust Certificates, each of which were heretofore qualified under the Act, is not so likely to involve a material conflict of interest as to make it necessary in the public interest or for the protection of investors to disqualify the bank from acting as trustee under any of such indentures. Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
