INVESTMENT COMPANY ACT RELEASES

STEIN ROE FLOATING RATE INCOME FUND, ET AL.

A notice has been issued giving interested persons until October 12, 1999, to request a hearing on an application filed by Stein Roe Floating Rate Income Fund, et al. for an exemption from Sections 18(c) and 18(i) of the Investment Company Act, Rule 23c-3 under the Act, and pursuant to Section 17(d) of the Act and Rule 17d-1 under the Act. The order would permit certain registered closed-end management investment companies to issue multiple classes of shares, and impose asset-based distribution fees and early withdrawal charges. (Rel. IC-24014 - September 15)

EVERGREEN VARIABLE ANNUITY TRUST, ET AL.

A notice has been issued giving interested persons until October 12, 1999, to request a hearing on an application filed by Evergreen Variable Annuity Trust (Trust) and Evergreen Asset Management Corp. (Adviser) (together, Applicants). Applicants seek an amended order pursuant to Section 6(c) of the Investment Company Act for exemptions from the provisions of Sections 9(a), 13(a), 15(a) and 15(b) of the Act and Rules 6e-2(b)(15) and 6e-3(T)(b)(15) thereunder to the extent necessary to permit shares of any current or future series of the Trust and shares of any other investment company that is designed to fund insurance products or to serve as an investment vehicle for qualified pension and retirement plans and for which the Adviser or any of its affiliates may now or in the future serve as investment adviser, administrator, manager, principal underwriter or sponsor, to be sold and held by the Adviser or any of its affiliates. FRANKLIN GOLD FUND, ET AL.

A notice has been issued giving interested persons until October 12, 1999, to request a hearing on an application filed by the Franklin Gold Fund, et al. for an order under (i) Section 6(c) of the Investment Company Act granting an exemption from Sections 18(f) and 21(b) of the Act; (ii) Section 12(d)(1)(J) of the Act granting an exemption from Section 12(d)(1) of the Act; (iii) Sections 6(c) and 17(b) of the Act granting an exemption from Sections 17(a)(1) and

17(a)(3) of the Act; and (iv) Section 17(d) of the Act and Rule 17d-1 under the Act. The order would permit certain registered management investment companies to participate in a joint lending and borrowing facility. (Rel. IC-24016 - September 16)
