INVESTMENT COMPANY ACT RELEASES

ILI ENDEAVOR VARIABLE ANNUITY ACCOUNT

An order has been issued under Section 8(f) of the Investment Company Act declaring that ILI Endeavor Variable Annuity Account has ceased to be an investment company. (Rel. IC-22357 - November 27)

CTGNA FUNDS GROUP, ET AL.
