COMMISSION ANNOUNCEMENTS

CHAIRMAN LEVITT APPOINTS TIMOTHY FORDE AS COUNSEL TO THE CHAIRMAN

Chairman Levitt announced on December 17 the appointment of Timothy J. Forde as Counsel to the Chairman. Mr. Forde, 39, is expected to advise the Chairman on a broad range of policy issues, including those arising in the area of investment management. (Press Rel. 96-141)

ENFORCEMENT PROCEEDINGS

CIVIL ACTION AGAINST MORRIS DABAH, ROBERT REISS, STANLEY GREENSTEIN AND DAVID KEERY

The Commission today announced the filing of a settled complaint in the United States District Court for the Southern District of New York alleging insider trading by Morris Dabah (Dabah) formerly CEO of The Gitano Group, Inc. (Gitano), Robert Reiss (Reiss), formerly Gitano's executive vice president and Stanley A. Greenstein (Greenstein), formerly Gitano's CFO, in violation of Section 17(a) of the Securities Act of 1933 (Securities Act), Section 10(b) of the Securities Exchange Act of 1934 (Exchange Act) and Rule 10b-5 thereunder; and financial fraud by Greenstein and David Keery (Keery) the senior financial officer, in violation of Sections 10(b) and 13(b)(5) of the Exchange Act and Rules 10b-5, 13b2-1 and 13b2-2 thereunder. The Commission's complaint alleges that in early 1992, Dabah and Reiss traded Gitano stock through accounts at foreign banks while in possession of material nonpublic information concerning Gitano's earnings, that Dabah, Reiss and Greenstein sold Gitano stock before Gitano disclosed a threat to a material line of credit and that Dabah and Reiss failed to file Forms 4 disclosing their trades in violation of Section 16(a) of the Exchange Act and Rule 16a-3 thereunder. The complaint also alleges Keery and Greenstein failed to establish a reserve on a timely basis for losses Gitano had incurred, thereby falsifying various of Gitano's financial statements filed with the Commission. Simultaneously with the filing of the complaint the defendants, without admitting or denying the allegations, consented to the entry of Final Judgments enjoining them from future violations of the federal securities laws; requiring Dabah, Greenstein, and Reiss to pay disgorgement and

interest of \$266,236.90, \$236,982.44, and \$97,831.47, respectively; and ordering Dabah, Greenstein, Reiss, and Keery to pay penalties of \$186,877.50, \$167,437.50, \$79,825, and \$25,000, respectively. CIVIL ACTION AGAINST PARRIS HOLMES, JR.

The Commission filed a civil injunctive action in U.S. District Court for the District of Columbia against Parris H. Holmes, Jr., alleging violations of the reporting requirements applicable to officers, directors, and certain shareholders of public companies. Simultaneously with the filing of the action, Holmes consented, without admitting or denying the Commission's allegations, to the entry of a Final Judgment permanently enjoining him from violating those requirements, and requiring him to pay a civil penalty of \$50,000.

The complaint alleges that the defendant, who was the Chairman and Chief Executive Officer of U.S. Long Distance Corp., failed to file timely twelve reports required by Section 16(a) of the Securities Exchange Act of 1934 and the rules thereunder reflecting certain of his purchases and sales of the securities of U.S. Long Distance Corp. He executed most of the subject transactions between August 1991 and November 1992 through accounts held by Abelard Ltd., a British Virgin Island trust. Holmes was the beneficial owner of the shares held by the trust. [SEC v. Parris H. Holmes, Jr., Civil Action No. 96-2793, TFH, D.D.C.] (LR-15190)

INVESTMENT COMPANY ACT RELEASES

VOYAGEUR TEXAS MUNICIPAL INCOME FUND

A notice has been issued giving interested persons until January 10 to request a hearing on an application filed by Voyageur Texas Municipal Income Fund for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. VOYAGEUR MISSOURI MUNICIPAL INCOME FUND, INC.

A notice has been issued giving interested persons until January 10 to request a hearing on an application filed by Voyageur Missouri Municipal Income Fund, Inc. for an order under Section 8(f) of the Investment Company Act declaring that applicant has ceased to be an investment company. (Rel. IC-22401 - December 16)

FREMONT MUTUAL FUNDS, INC., ET AL.

An order has been issued on an application filed by Fremont Mutual Funds, Inc. (Company) and Fremont Investment Advisors, Inc. under

Section 6(c) of the Investment Company Act to exempt applicants from Section 15(a) of the Act and Rule 18f-2 thereunder. The order permits subadvisers approved by the Company's board of directors to serve as portfolio managers (Managers) for the Company's series of shares without obtaining shareholder approval of the agreements with the Managers. HOLDING COMPANY ACT RELEASES

MAINE YANKEE ATOMIC POWER COMPANY

A supplemental order has been issued authorizing Maine Yankee Atomic Power Company (Maine Yankee), an indirect nuclear generating subsidiary company of Northeast Utilities and New England Electric System, registered holding companies, to issue, sell and renew its short-term notes and commercial paper in outstanding aggregate principal amounts of up to \$21 million, through December 31, 2001. (Rel. 35-26629)

SELF-REGULATORY ORGANIZATIONS

PROPOSED RULE CHANGE

The Government Securities Clearing Corporation filed a proposed rule change (SR-GSCC-96-13) to make the Department of Treasury's Treasury Inflation Protection Security eligible for clearance and settlement at GSCC. Publication of the proposal is expected in the Federal Register during the week of December 16. (Rel. 34-38048)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the National Association of Securities Dealers (SR-NASD-96-40) to amend the inclusion criteria for the Supplemental List of the Mutual Fund Quotation Service. Publication of the proposal is expected in the Federal Register during the week of December 23. (Rel. 34-38052)

The Commission has approved a proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-95-48) relating to the use of proprietary brokerage order routing terminals on the floor of the Exchange. (Rel. 34-38054)
