ENFORCEMENT PROCEEDINGS

FINAL JUDGMENT ENTERED AGAINST REHAN MALIK

The Commission announced today that on December 18 the United States District Court for the District of Columbia entered a Final Judgment of Permanent Injunction as to Defendant Rehan Malik. Malik is a former President of Wye Resources, Inc., a Canadian corporation. The complaint against Wye and Malik was filed on September 26, 1996 and alleges that Malik participated in a fraudulent promotional campaign targeted towards U.S. investors and improperly distributed over 2.5 million shares of Wye stock to U.S. investors that were not properly issued under Canadian law nor registered with the Commission.

Without admitting or denying the allegations of the complaint, Malik consented to the entry of a permanent injunction prohibiting violations of Section 5 of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10-b thereunder. Malik also consented to pay a penalty in the amount of \$25,000. For further information see SEC v. Wye Resources, Inc. and Rehan Malik, Lit.
