LAST DAY TO SUBMIT CARREL APPLICATIONS

Pursuant to the rules of the Commission's Public Reference Room, applications for the January allocation of carrels and telephone privileges for recognized user organizations (information dissemination companies) are now being accepted. Application forms are available in the Public Reference Room. Information dissemination companies that are unable to pick up forms in Washington may submit applications by writing to Stephen L. McConnell, Branch Chief, Public Reference, Securities and Exchange Commission, Room 1024, Mail Stop 1-2, 450 Fifth Street, N.W., Washington, D.C. 20549. Applications must include: a brief description of the business, business address and telephone number, the name of a person who will serve as on-site contact in the Room, and the names of all persons who work everyday in the Room, number of employees assigned

to research/sales of SEC filings, regardless of work location, and number of carrels requested. Applicants may also submit a supplemental statement in support of their request for carrels/telephone privileges. The applications must be certified and signed by a responsible company official, and submitted by the close of business January 27, 1995. As in the past, the assignment of carrels/telephone privileges is discretionary. The Commission intends to continue to reserve carrels for the general public.

Revised carrel allocations will be effective February 27, 1995. Questions concerning application procedures may be addressed to Stephen L. McConnell, Branch Chief, at (202) 942-8078.

ENFORCEMENT PROCEEDINGS

CEASE AND DESIST ORDER ISSUED AGAINST STANLEY BERK

The Commission today announced the entry of Findings, Cease and Desist Order Pursuant to Section 21C of the Exchange Act of 1934 (Exchange Act), and Remedial Sanctions (Order) against Stanley Berk (Berk) finding that Berk violated Sections 10(a) and 10(b) of the Exchange Act and Rule 10b-21 thereunder [17 C.F.R. § 240.10b-21, originally adopted as 17 C.F.R. § 240.10b-21(T)]. Simultaneous with the entry of the Order, the Commission accepted Berk's Offer of Settlement in which he, without admitting or denying the findings, consented to the entry of the Order requiring him to cease and desist from committing violations and agreed to the disgorgement of illegal profits.

The Commission found that, Berk, with respect to eight public offerings, sold securities short during the period after the registration statement was filed, but before the offered shares became publicly available, and subsequently covered the short positions with securities purchased in the public offerings, violating Sections 10(a) and 10(b) of the Exchange Act and Rule 10b-21 thereunder. The Commission further found that Berk realized illegal profits and ordered him to disgorge profits of \$40,667.75 with interest thereon of \$11,976.52. (Rel. 34-35254)

INVESTMENT COMPANY ACT RELEASES

AMBASSADOR FUNDS, ET AL.

A notice has been issued giving interested persons until February 21 to request a hearing on an application filed by Ambassador Funds, et al. for a conditional order under Section 6(c) of the Investment Company

Act exempting applicants from the provisions of Section 15(a). The order would permit the implementation, without shareholder approval, of a new investment advisory agreement for each applicant investment company (Fund) for a period of up to 120 days (Interim Period) after the termination of the existing investment advisory agreement of each Fund as a result of the transfer of the investment advisory businesses of the current advisers of the Funds (Advisers) to a partnership (New Adviser) formed by the Advisers. The order also would permit the New Adviser to receive fees earned under the new investment advisory agreements during the Interim Period following approval of the agreements by the Fund shareholders. FINANCIAL HORIZONS VARIABLE SEPARATE ACCOUNT - 2, ET AL.

A notice has been issued giving interested persons until February 21 to request a hearing on an application filed by Financial Horizons Variable Separate Account - 2 (Separate Account), Financial Horizons Life Insurance Company (Company), and Nationwide Financial Services, Inc. Applicants seek an order under Section 6(c) of the Investment Company Act granting exemptions from Sections 26(a)(2)(C) and 27(c)(2) of the Act, to the extent necessary to permit payment to the Company of a mortality and expense risk charge from the assets of the Separate Account under certain variable annuity contracts. HOLDING COMPANY ACT RELEASES

THE SOUTHERN COMPANY, ET AL.

An order has been issued granting a proposal by The Southern Company (Southern), a registered holding company, and The Southern Development and Investment Group, Inc. (Development). Southern proposes to make additional equity investments in Development of up to \$275 million, and Development proposes to use such funds from time to time through December 31, 1998, to fund the following proposed activities to enable Development to develop, construct or acquire a prototype energy management network; to finance the cost of equipment or provide customer financing of equipment in connection with energy management and efficiency services provided by Development; to fund the estimated costs of commercializing the POWERcall(tm) technology; for working capital in connection with its research and development activities; to pay development costs associated with potential investments in energy and resource recovery facilities; for technical consulting activities; and to fund the licensing of intellectual property to non-affiliates. Southern also proposes, from time to time through December 31, 2003, to guarantee or to act as surety itself on obligations issued or undertaken by Development in connection with its proposed business activities in an aggregate amount outstanding at any one time of \$200 million. Jurisdiction is reserved over certain related matters. (Rel. 35-26221)
