## ENFORCEMENT PROCEEDINGS

---

### BLYTHE SELDEN IS PERMANENTLY BARRED AND HIS REGISTRATION AS AN INVESTMENT ADVISER IS REVOKED

The Commission announced an Order Instituting Proceedings, Making Findings and Imposing Remedial Sanctions (Order) against Blythe Olin Selden (Selden), a resident of Linden, Michigan and an investment adviser registered with the Commission. The Order found that Selden violated the registration and antifraud provisions of the federal securities laws by engaging in the fraudulent offer and sale of unregistered promissory notes. Specifically, the Order found that between 1984 and April 1994, Selden, through Shiawassee Shores Retirement Park, Inc. (Shiawassee), a Michigan corporation of which Selden is the sole shareholder, sold at least \$5.1 million in unregistered promissory notes to approximately 200 investors in at least four states. Furthermore, the Order found that Selden omitted to state material facts and made material misrepresentations to investors concerning the use of proceeds, the financial condition of Shiawassee and the risks involved in investing. The Order also found that on April 28, 1994, Selden was permanently enjoined by a U.S. District Court from further violations of the registration and antifraud provisions of the federal securities laws.

Selden consented to the entry of the Order without admitting or denying the Commission's findings, except for the entry of the order of permanent injunction. The Commission's Order bars Selden from association with any broker, dealer, investment adviser, investment company or municipal securities dealer and revokes his registration as an investment adviser. ## COURT FINDS MICHAEL MCINTYRE IN CIVIL CONTEMPT AND ISSUES BENCH WARRANT FOR HIS ARREST

On March 7, the United States District Court for the Central District of California entered an Order Adjudging Michael McIntyre in Civil Contempt and issued a bench warrant for McIntyre's arrest. The Commission had requested that the Court hold McIntyre in contempt as a result of McIntyre's failure to comply with a December 19, 1994 Order (Order) of the Court requiring McIntyre to comply with a subpoena duces tecum issued to him by the Commission.

On approximately March 29, 1995, McIntyre was taken into custody by the United States Marshals Service and incarcerated. McIntyre has since complied with the Order by producing documents required by the subpoena to the Commission and has been released from custody. [SEC v. Michael McIntyre, Civil Action No. 94-8036 DT(Ex), C.D. Cal.] (LR-14497)

## FEDERAL COURT ORDERS CLIFF SHARFMAN ENJOINED FOR ONE YEAR

The Commission announced that on April 21, following a trial, the Honorable John E. Sprizzo of the United States District Court for the Southern District of New York issued a decision enjoining Cliff Sharfman, a registered representative formerly associated with Stratton Oakmont, Inc., from employment in the securities business for a period of one year. Sharfman was employed by Stratton Oakmont as a broker from April 1989 to July 1990 and also from September 1990 to June 1991. In his decision, Judge Sprizzo found that Sharfman violated the antifraud provisions of the federal securities laws in that he solicited customers to buy and sell securities for his own benefit and for the benefit of Stratton Oakmont, and not in the best interests of his customers. The Court also ordered Sharfman to disgorge ill-gotten gains, in an amount to be determined later. [SEC v. Stratton Oakmont, Inc., et al., 92 Civ. 1993, JES] (LR-14498)

## INVESTMENT COMPANY ACT RELEASES

---

### COLUMBIA VENTURES, INC.

An order has been issued under Section 8(f) of the Investment Company Act declaring that Columbia Ventures, Inc. has ceased to be an investment company. (Rel. IC-21058 - May 10)

## NIKE SECURITIES L.P., ET AL.

An order has been issued on an application filed by Nike Securities, L.P., et al., under Section 6(c) of the Investment Company Act for an exemption from Sections 2(a)(32), 2(a)(35), 22(d), and 26(a)(2) of the Act, and Rule 22c-1 thereunder, and under Section 11(a) of the Act for an exemption from Section 11(c) of the Act. The order permits applicants to assess a deferred sales charge on trust units, and to waive such charge in certain instances. The order also permits exchanges of trust units having front-end and deferred sales charges. (Rel. IC-21059 - May 10)

## SELF-REGULATORY ORGANIZATIONS

---

### PROPOSED RULE CHANGES

The Philadelphia Stock Exchange filed a proposed rule change (SR-PHLX-95-13) to amend PHLX Rules 1001, "Position Limits," and 1002, "Exercise Limits," to increase the position and exercise limits for foreign currency options to 200,000 contracts. Publication of the notice is expected in the Federal Register during the week of May 15. (Rel. 34-35688)

The Philadelphia Stock Exchange filed a proposed rule change (SR-PHLX-95-16) to amend PHLX Rules 1001A, "Position Limits," and 1002A, "Exercise Limits," to increase the position and exercise limits for industry index options from 5,500, 7,500, or 10,500 contracts to 6,000, 9,000, or 12,000 contracts. Publication of the notice is expected in the Federal Register during the week of May 15. (Rel. 34-35694)

The Philadelphia Stock Exchange filed a proposed rule change (SR-PHLX-95-22) that would list and trade options on the Phlx Super Cap Index, a capitalization weighted index developed by the Phlx composed of the five largest stocks, by capitalization, traded on the New York Stock Exchange. Publication of the notice is expected in the Federal Register during the week of May 15. (Rel. 34-35699)

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-Amex-95-16) filed by the American Stock Exchange relating to minimum fractions of trading in Standard & Poor's MidCap 400 Depositary Receipts has become effective pursuant to Section 19(b)(3)(A) of the Securities Exchange Act of 1934. Publication of the filing is expected in the Federal Register during the week of May 15. (Rel. 34-35689)

## APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change (SR-CBOE-95-06) submitted by the Chicago Board Options Exchange to grant the senior person in charge of the Control Room the authority to turn off the Retail Automatic Execution System (RAES) if there is a system malfunction that affects the Exchange's ability to disseminate or update market quotes. Publication of the approval order is expected in the Federal Register during the week of May 15. (Rel. 34-35695)

The Commission approved a proposed rule change filed by the National Securities Clearing Corporation (SR-NSCC-94-19) which enables NSCC to offer same-day money settlement capabilities as part of its Fund/Serv service. (Rel. 34-35696)
