### EDGAR PHASE-IN LIST UPDATES AVAILABLE TO PUBLIC

On December 19, 1994, the Commission issued a release making the interim Electronic Data Gathering, Analysis, and Retrieval (EDGAR) rules final and setting forth revised phase-in schedules and lists to achieve full implementation of mandated electronic filing (Release No. 33-7122, published in the Federal Register on December 30, 1994 [59 FR 67752] (Adopting Release). Pursuant to Rule 901 of Regulation S-T, registrants whose filings are processed by the Division of Corporation Finance may request a change in the date they become subject to mandated electronic filing on the EDGAR system. A change to a registrant's phase-in date is of particular importance to persons or entities filing documents with respect to that registrant, since generally such persons must file electronically when the registrant becomes subject to electronic filing.

Updates to the Division of Corporation Finance phase-in list, reflecting changes and corrections, will continue to be published in the SEC News Digest. Copies of the phase-in list updates will be available through the Commission's public reference room and posted on the EDGAR electronic bulletin board. Cumulative phase-in list changes will be published periodically in the Federal Register. ## ENFORCEMENT PROCEEDINGS

---

### ROGER PETERKIN, III CENSURED

The Commission today announced the entry of an Order Making Findings and Imposing Remedial Sanction Pursuant to Sections 15(b) and 19(h) of the Securities Exchange Act of 1934 against Roger O. Peterkin, III, the former director of operations of J. Edmund & Co. (Edmund), a registered broker-dealer located in Milton, Massachusetts. Peterkin is a resident of Wellesley, Massachusetts.

The Commission found that Peterkin willfully aided and abetted Edmund's violations of Sections 7(c) and 11(d)(1) of the Securities Exchange Act of 1934 and Regulation T enacted pursuant to Section 7(c). Edmund violated Section 7(c) and Regulation T by repeatedly failing to obtain timely payment for purchases of securities by its customers. Edmund violated Section 11(d)(1) by extending credit to purchasers of a new issue of a security for which Edmund had acted as the managing underwriter within thirty days prior to the purchases. The Commission found that Peterkin administered the operations of Edmund and reviewed Edmund's client account statements and other records to determine whether Edmund was in compliance with Regulation T. The Order censures Peterkin. (Rel. 34-35686)

### MONTGOMERY ASSET MANAGEMENT, L.P., ET AL.

An order has been issued on an application filed by Montgomery Asset Management, L.P. (Montgomery) and The Montgomery Funds III (Fund), pursuant to Section 6(c) of the Investment Company Act, granting exemptions from the provisions of Sections 9(a), 13(a), 15(a), and 15(b) of the Act and Rules 6e-2(b)(15) thereunder. The order provides exemptions to the extent necessary to permit shares of the Fund and certain other investment companies for which Montgomery or an affiliate of Montgomery serves as investment adviser, administrator, manager, principal underwriter or sponsor to be sold to and held by variable annuity and variable life insurance separate accounts of both affiliated and unaffiliated life insurance companies and qualified pension and retirement plans.
