RULES AND RELATED MATTERS

TECHNICAL AMENDMENTS TO RULES AND FORMS ADOPTED

The Commission adopted amendments to various rules and forms under the Securities Acts. These amendments eliminate rules which are duplicative of generally accepted accounting principles or otherwise unnecessary, clarify language or conform rules to existing staff interpretations and correct technical omissions and errors. These rules are effective upon publication in the Federal Register. (Rel. 33-6612; PFR-22)

COMMENTS REQUESTED ON REPROPOSAL OF RULE REVISION AND RULE AMENDMENT

The Commission is proposing for public comment a repropoed revision of Rule 70 and amendments to Rule 50 under the Public Utility Holding Company Act of 1935. The revision of Rule 70 would simplify and expand the exemptions now available under the existing rule which permit persons affiliated with investment bankers and commercial banking institutions to serve as officers or directors of registered holding companies and their subsidiaries. The amendments to Rule 50 would codify revised competitive bidding procedures and address potential conflicts of interest. The Commission has redrafted the revisions to Rule 70 and amendments to Rule 50 to reflect certain comments received following the initial proposal earlier this year.

CIVIL PROCEEDINGS

COMPLAINT NAMES NORTH AMERICAN INDUSTRIES, INC., OTHERS

The New York Regional Office filed a complaint on November 20 in the U.S. District Court for the Southern District of New York against North American Industries, Inc. (NAI), Miriam Lazofsky (M. Lazofsky), Daniel Claridy, Giacomo (Jack) Illare, Saul Lazofsky (S. Lazofsky), and Richard Russo.

The complaint alleges that: NAI, M. Lazofsky, Claridy and Illare participated in an unregistered distribution of shares of NAI common stock in violation of the registration provisions of the securities laws; NAI, M. Lazofsky and S. Lazofsky disseminated false and misleading information to the public regarding NAI in violation of the anti-fraud provisions of the securities laws; and Claridy and Russo fraudulently created the impression of an active market in NAI's common stock in violation of the antifraud provisions of the Securities Exchange Act of 1934 and Rule 10b-5.

The complaint seeks injunctions against all of the defendants and other equitable relief. (SEC v. North American Industries, Inc., et al., 85 Civil 9116, SDNY). (LR-10940)

INVESTMENT COMPANY ACT RELEASES

TAX-FREE INCOME PORTFOLIOS, INC.
