RULES AND RELATED MATTERS

SIMPLIFICATION OF REGISTRATION AND REPORTING REQUIREMENTS FOR FOREIGN COMPANIES CORRECTION

On May 12, the Commission published corrections to final rules which were published April 26, 1994 [59 FR 21644]. The rules relate to foreign issuer eligibility to use short-form and shelf registration, financial statement reconciliation and financial statement schedule requirements for foreign issuers, safe harbor protection for analyst reports with respect to sizable foreign companies publicly traded offshore and safe harbor protection for certain company announcements regarding exempt offerings or unregistered offshore offerings. ENFORCEMENT PROCEEDINGS

SENIOR FINANCIAL ADVISER TO TIME WARNER SETTLES INSIDER TRADING CHARGES

The Commission announced that on May 5 it filed a civil injunctive action in the United States District Court for the Southern District of New York against Oded Aboodi (Aboodi), in connection with alleged illegal trading in the securities of Time Warner, Inc. (Time Warner), prior to the June 6, 1991 announcement by Time Warner of the approval of a controversial stock rights plan (Plan). Simultaneously with the filing of the complaint, Aboodi consented to the entry of an injunction against future violations of Section 17(a) of the Securities Act of 1933 and Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder, disgorgement of losses avoided of \$413,700, prejudgment interest of \$103,677.51, and a penalty of \$413,700, pursuant to the Insider Trading and Securities Fraud Enforcement Act of 1988.

The complaint alleges that on or before May 30, 1991, Aboodi, a financial adviser to, and employee of, Time Warner and a close friend and business adviser of Steven Ross, former Time Warner co-chief executive officer, received confidential information that Time Warner management was considering the implementation of the Plan, that the Plan

was likely to have a substantial negative impact on the price of Time Warner common stock, and that the Plan would have a neutral to slightly positive effect on the price of Time Warner preferred stock. While in possession of this information, Aboodi directly or indirectly caused family partnerships which he controlled to sell 20,000 shares of Time Warner common stock, and use the proceeds from the sale to purchase Time Warner preferred stock. By directly or indirectly causing the partnerships to sell Time Warner common stock when he did, Aboodi caused the partnerships to avoid losses of \$413,700. [SEC v. INVESTMENT COMPANY ACT RELEASES

WNC CALIFORNIA HOUSING TAX CREDITS IV, L.P., SERIES 4 THROUGH 9 AND WNC CALIFORNIA TAX CREDIT PARTNERS IV, L.P.

An order has been issued on an application filed by WNC California Housing Tax Credits IV, L.P., Series 4 through 9 (Partnership) and WNC California Tax Credit Partners IV, L.P. under Section 6(c) of the Investment Company Act. The order exempts the Partnership from all provisions of the Act and permits the Partnership to invest in limited partnerships that engage in the ownership and operation of apartment complexes for low and moderate income persons. ITT HARTFORD LIFE AND ANNUITY INSURANCE COMPANY, ET AL.

An order has been issued pursuant to Section 6(c) of the Investment Company Act exempting ITT Hartford Life and Annuity Insurance Company, ITT Hartford Life and Annuity Insurance Company/Separate Account One (Account) and Hartford Equity Sales Company, Inc. from the provisions of Sections 26(a)(2)(C) and 27(c)(2) of the Act. The order provides exemptions to the extent necessary to permit the deduction of a mortality and expense risk charge from the assets of the Account under certain variable annuity contracts. (Rel. THE MUTUAL LIFE INSURANCE COMPANY OF NEW YORK, ET AL.

A notice has been issued giving interested persons until June 6 to request a hearing on an application filed by The Mutual Life Insurance Company of New York and Keynote Series Account for an order approving the substitution of beneficial interests in the portfolios of the Diversified Investors Portfolios for the shares of the MONY Series Fund, Inc. that are held currently by the Keynote Series Account. HARBOR FUND

An order has been issued on an application filed by Harbor Fund under Sections 6(c) and 17(b) of the Investment Company Act granting relief from Section 17(a) of the Act to permit Owens-Illinois Master Retirement Trust, a shareholder of an investment portfolio of the Fund, who is an "affiliated person" of the portfolio, to redeem portfolio shares for payment in-kind. HOLDING COMPANY ACT RELEASES

MONONGAHELA POWER COMPANY, ET AL.

An order has been issued regarding a proposal by Monongahela Power Company, The Potomac Edison Company, and West Penn Power Company (collectively, Companies), all wholly owned public-utility subsidiary companies of Allegheny Power System, Inc., a registered holding company. The Companies propose to arrange for the issuance of three new series of pollution control revenue bonds (Refunding Bonds) in the aggregate principal amount of \$23.4 million. The Refunding Bonds will be used to refund outstanding pollution control revenue bonds previously issued on behalf of the Companies. (Rel. 35-26051)

SELF-REGULATORY ORGANIZATIONS

WITHDRAWAL GRANTED

An order has been issued granting the application of International Colin Energy Corporation to withdraw from listing and registration its Common Shares Without Nominal or Par Value, on the American Stock Exchange. (Rel. 34-34045)

IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change (SR-NASD-94-18) filed by the National Association of Securities Dealers to eliminate certain data stream subscriber fees has become effective upon filing with the Commission. Publication of the proposal is expected in the Federal Register during the week of May 16. (Rel. 34-34029)

APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change (SR-Phlx-93-39) filed by the Philadelphia Stock Exchange to adopt a supervision rule. (Rel. 34-34044)
