COMMISSION ANNOUNCEMENTS

SAB NO. 69

The Commission issued Staff Accounting Bulletin No. 69 to provide its view regarding: (a) the application of Article 9 of Regulation S-X and Industry Guide 3 as guidance for certain disclosures of registrants which are not bank holding companies, but which are engaged in similar lending and deposit activities; and (b) income statement presentation for casino-hotel activities. ADMINISTRATIVE PROCEEDINGS

BENJAMIN REUBEN AND LYMAN COLE BARRED

The Commission instituted administrative proceedings against Benjamin B. Reuben and Lyman Cole. The Order for Proceedings (Order) alleges that at various times from 1981 through 1983, Reuben, former owner and President of Midwest Discount Securities, violated and/or aided and abetted violations of, among others, the registration and antifraud provisions of the securities laws in that he sold unregistered securities while failing to disclose that the prices at which the securities were sold were arbitrarily determined and that transactions by insiders of Midwest served to create the appearance of activity in the stock. The Order also alleges that Cole, former Compliance Officer of Midwest, aided and abetted violations of the registration and other provisions of the securities laws. Simultaneously, the Commission accepted Reuben's and Cole's Offers of Settlement. They consented to permanent bars from association with any broker, dealer, municipal securities dealer, investment company, or investment adviser in supervisory or proprietary capacities. Reuben consented to a bar from association with the above in any capacity with a right to reapply in two years, and Cole consented to a suspension from association with the above in any capacity for eight months. NASD'S REFUSAL TO PERMIT EMPLOYMENT
OF MICHAEL B. SCHEFT AFFIRMED

The Commission affirmed the NASD's refusal to permit one of its member firms to employ Michael B. Scheft, of Helotes, Texas, as a salesman. The member's request was necessary because, in September 1985, Scheft was convicted of mail fraud.

The Commission stated that it shared the NASD's concern over the serious nature of Scheft's misconduct, the facts that his conviction was recent and he is still on probation, and the questionable supervision that he would receive in his proposed employment. It concluded that the NASD's action was fully warranted in order to protect public investors. (Rel. 34-24417)

CIVIL PROCEEDINGS

BENJAMIN B. REUBEN ENJOINED

The Chicago Regional Office announced that on May 4 an Order of Permanent Injunction was entered against Benjamin B. Reuben. The Order, entered pursuant to Reuben's consent, enjoins Reuben from violations of the registration, net capital, books and records, and various antifraud provisions of the securities laws.

among other things, that Reuben violated and aided and abetted violations of the registration and antifraud provisions of the securities laws in connection with the offer and sale of securities in the form of common stock of Continental Energy Corporation (CEC). From June 1982 until at least June 1983, Reuben, through Midwest Discount Securities, a broker-dealer formerly owned by Reuben, sold the unregistered CEC securities while failing to disclose that the prices at which CEC stock was purchased and sold were arbitrarily determined, and that transactions by CEC insiders served to create the appearance of market activity in CEC stock. In addition, Reuben caused Midwest to publish quotations for CEC stock while not having in its records certain required information about the company. (SEC v. Benjamin B. APPROVAL OF PROPOSED RULE CHANGE

The Commission approved a proposed rule change filed by the Options Clearing Corporation (SR-OCC-86-16) adopting its Rule 801(e), which authorizes OCC to accept late filings, revocations, and modifications of option exercise notices from its clearing members after 7:00 p.m. (Central Time) deadlines. NOTICE OF PROPOSED RULE CHANGE

The Philadelphia Depository Trust Company filed a proposed rule change under Rule 19b-4 (SR-PHILADEP-87-1) amending its by-laws to authorize its president to be counted as an Exchange governor solely for the purpose of satisfying the requirement that a majority of its directors be Exchange governors. Publication of the proposal is expected to be made in the Federal Register during the week of May 11. (Rel. 34-24432)
