ADMINISTRATIVE PROCEEDINGS

THOMAS J. FITTIN, JR. BARRED

Administrative Law Judge David J. Markun issued an initial decision barring Thomas J. Fittin, Jr. from association with a broker or dealer with the proviso that after 15 months he may reapply to become so associated in a non-proprietary, non-principal, non-supervisory capacity upon satisfactory showing that he will be adequately supervised.

The sanction is based upon findings that Fittin wilfully violated the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 and Rule 10b-5 in 1981 and 1982 in connection with the sale of securities, i.e., limited partnership interests in three oil and gas drilling programs in Texas offered by Major Exploration, Inc., the general partner in each program. During the relevant period, Fittin was the president, principal shareholder, and head of retail sales of Fittin, Cunningham and Lauzon (FCL), a registered broker-dealer. FCL and Fittin acted as an underwriter, broker, and offeree representative in each of the three drilling programs offered and sold by Major and FCL.

The initial decision is subject to review by the Commission on its own motion or on petition of a party.

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by: The Pacific Stock Exchange (SR-PSE-86-26) to impose new requirements on its floor members who act as both market brokers and floor brokers. (Rel. 34-24769); and The National Association of Securities Dealers (SR-NASD-87-23) to amend Article III, Sections 21(b) and 41, of its Rules of Fair Practice and the Board of Governors' Interpretation on Prompt Receipt and Delivery of Securities to clarify the applicability of its short sale rules to various types of securities.
