## COMMISSION ANNOUNCEMENTS

---

### EDGAR CONFERENCE

The SEC Office of EDGAR Management will hold the fifth EDGAR Conference in Room IC30 of the Judiciary Plaza Building at 450 5th Street, N.W., Washington, D.C. It will take place between 10:00 a.m. and 5:00 p.m., on Wednesday, January 29, 1992.

The conference agenda will include an overview of the recent changes in the operational EDGAR development schedule, anticipated rulemaking, EDGAR registration procedures and data dissemination plans. There will also be a demonstration of the latest EDGARLink software.

Filers who have or intend to submit test filings to the operational EDGAR system are encouraged to share their experiences in an open forum at the conference.

## ADMINISTRATIVE PROCEEDINGS

---

### STEVEN SANDERS BARRED

The Commission announced that it has ordered that Steven M. Sanders (Sanders) be permanently barred from association with any broker, dealer, municipal securities dealer, investment adviser or investment company. Sanders failed to answer the order which instituted administrative proceedings on September 30, 1991. The Commission found, based on the order instituting the proceedings, that from at least 1986 to 1989 Sanders was a person associated with a registered broker-dealer. The order also found that on July 22, 1991 Sanders was enjoined by the U.S. District Court for the Central District of Illinois for violating the antifraud and broker-dealer registration provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934. Further, the order found that from at least 1986 to 1989 Sanders willfully violated the antifraud and broker-dealer registration provisions of the federal securities laws by engaging in the fraudulent offer and sale of investment contracts to at least twenty investors in three states, from whom he obtained approximately \$300,000. ## INVESTMENT COMPANY ACT RELEASES

### BULL & BEAR OVERSEAS FUND LTD., ET AL.

A notice has been issued giving interested persons until February 14 to request a hearing on an application filed by Bull & Bear Overseas Fund Ltd. (Overseas) and Bull & Bear Equity-Income Fund (Equity-Income), et al. The application is for an order under Section 17(b) of the Investment Company Act exempting applicants from Section 17(a), and pursuant to Section 17(d) and Rule 17d-1 thereunder, permitting Overseas to acquire substantially all of the assets of Equity-Income for shares of Overseas. ## HOLDING COMPANY ACT RELEASES

---

### CENTRAL AND SOUTH WEST CORP., ET AL.

A notice has been issued giving interested persons until February 10 to request a hearing on a proposal by Central and South West Corporation, a registered holding company, and three of its nonutility subsidiaries, CSW Energy, Inc. (Energy), CSW Development-I, Inc. (Energy Sub) and ARK/CSW Development Partnership (collectively, Applicants), to acquire a 122.2 megawatt gas-fired cogeneration facility (the Project). The total cost of the Project, located near Bartow in Polk County, Florida, is expected to be approximately \$140 million. The Applicants propose to create a new subsidiary (Partnership) to own and operate the Project. The Applicants also propose to organize and acquire for \$1,000 all of the common stock of a new subsidiary (JV Sub), which would be the general partner of the Partnership. The Applicants further propose to borrow under a credit facility an aggregate amount not to exceed \$120 million in order to finance construction of the Project and arrange for letters of credit to be issued by third party lenders. Additionally, the Applicants propose to make capital contributions to Partnership in an aggregate amount of up to \$11 million and obtain authorization for the Partnership to enter into a construction agreement with Energy or Energy Sub. ### ENTERGY CORPORATION, ET AL.

A notice has been issued giving interested persons until February 10 to request a hearing on a proposal by Entergy Corporation (Entergy), a registered holding company, and its wholly owned public-utility subsidiary company, Mississippi Power & Light Company (MP&L). MP&L proposes to issue and sell from time to time through December 31, 1993, and Entergy proposes to acquire an aggregate of up to 2,173,914 additional shares of MP&L's common stock, no par value, for an aggregate consideration not to exceed \$50,000,022. ## SELF-REGULATORY ORGANIZATIONS

---

### IMMEDIATE EFFECTIVENESS OF PROPOSED RULE CHANGE

A proposed rule change filed by the Chicago Board Options Exchange (SR-CBOE-91-47) has become effective under Section 19(b)(3)(A) of the Securities Exchange Act of 1934. The proposed rule change clarifies that CBOE members are not obligated to report sell transactions in certain S&P 500 stock index option classes to price reporters in instances where the sale is executed by an Electronic Book on the Exchange. Publication of the proposal is expected in the Federal Register during the week of January 27. (Rel. 34-30268)

Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
