U.S. SECURITIES

MICHAEL LLOYD AND WARREN NACHMANN BARRED AND LLOYD SECURITIES, INC. REGISTRATION REVOKED

The Commission announced that on April 3 an Order Making Findings and Imposing Remedial Sanctions by Default (Order) was issued against Lloyd Securities, Inc. (Lloyd Securities), Michael W. Lloyd (Lloyd) and Warren C. Nachmann (Nachmann). The Order revoked the registration of Lloyd Securities, a broker-dealer registered with the Commission and barred Lloyd and Nachmann, president and vice-president, respectively, of Lloyd Securities, from associating with any broker, dealer, municipal securities dealer, investment adviser or investment company. The Order Instituting Proceedings (Order Instituting) found that Lloyd Securities, Lloyd and Nachmann had been permanently enjoined from violating the registration, antifraud and net capital provisions of the federal securities laws (SEC v. Lloyd Securities, Inc. et al., Civil Action No. 90-3841, E.D. Pa.). In addition, the Order Instituting found that Lloyd Securities, Lloyd and Nachmann engaged in a scheme to defraud investors by removing funds from customer accounts without authorization and converting customer funds to the use of Lloyd and Nachmann. Further, the Order Instituting found that Lloyd Securities, Lloyd and Nachmann engaged in a scheme to defraud investors by failing to redeem customer investments upon demand, offering and selling to customers of Lloyd Securities unregistered securities, omitting to disclose the use of investor proceeds and the nature of the underlying security or the risks involved.
