The subject matter of the October 29 closed meeting will be: Regulatory matter regarding financial institutions; and Institution of administrative proceedings of an enforcement nature.

#### OPEN MEETING - WEDNESDAY, OCTOBER 30, 1991 - 10:00 A.M.

The subject matter of the October 30 open meeting will be:

Consideration of whether to adopt amendments to Forms S-4 and F-4, Regulation S-K under the Securities Act of 1933 and related rules that provide additional disclosure requirements for roll-up transactions. These changes are intended to enhance the quality and readability of information provided to investors in connection with roll-up transactions and would set a minimum solicitation period for roll-up transactions. ## SELF-REGULATORY ORGANIZATIONS

### ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved on an accelerated basis a proposal (SR-PHLX-91-33) filed by the Philadelphia Stock Exchange under Rule 19b-4 to increase from ten to twenty contracts the size of customers orders that are eligible for automatic execution through the PHLX's Automated Options Market System. Publication of the proposal is expected in the Federal Register during the week of October 21. (Rel. 34-29837)

## ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
