ENFORCEMENT ACTIONS

INITIAL DECISION SUSPENDS THOMAS CANON, JR. AND ORDERS HIM TO CEASE AND DESIST FROM VIOLATING SECTION 10(b) OF THE SECURITIES EXCHANGE ACT AND RULE 10b-5

Administrative Law Judge Edward J. Kuhlmann has issued an initial decision suspending Thomas Q. Canon, Jr. for six months from association with any broker or dealer. The decision also permanently orders Canon to cease and desist from committing or causing any violation and committing or causing any future violation of Section 10(b) of the Securities Exchange Act of 1934 and Rule 10b-5 thereunder.

The initial decision found that Canon, a registered representative in Salt Lake City, Utah, willfully aided and abetted Richard L. Warner's trading of the stock of Automated Language Processing Systems, Inc. in violation of the antifraud provisions of the Securities Exchange Act. Warner's stock transactions took place over a two and one-half year period from June 19, 1987 through December 11, 1989. Among other practices, Warner, engaged in an effort to manipulate the price of ALPS stock by making numerous small lot purchases to move the price of the stock to the ask side. These transactions took place throughout the trading day and, frequently, at the close of the market. Canon served as account executive for four accounts that Warner controlled. (Initial Decision Rel. No. 41)

PROCEEDINGS INSTITUTED AGAINST SIX INDIVIDUAL OFFICERS AND EMPLOYEES OF FIRST INVESTORS CORPORATION

The Commission announced that on December 8 it simultaneously instituted and settled administrative proceedings pursuant to Section 15(b) of the Securities Exchange Act of 1934 against David D. Grayson, Glenn O. Head, Sam Siegel, Howard Froman, Alvin Blumenfeld and Louis Woolf (Respondents). The Respondents, respectively First Investors Corporation's (First Investors) president, chairman, former head of its Executive Sales Department, and the heads of several sales divisions, consented to the issuance of the Order without admitting or denying the Commission's findings.

On the basis of the Order and Respondents' Offers of Settlement, the Commission found that from approximately 1984 through approximately 1990 certain of First Investors' representatives fraudulently sold shares of two high yield mutual funds affiliated with First Investors (Funds) by making material misrepresentations and omissions concerning the risk of investing in the Funds and the performance of the Funds, and selling shares of the Funds to some investors for whom they were unsuitable. The Commission further found that Respondents failed reasonably to supervise the representatives by failing to establish appropriate procedures and to respond reasonably to indications that First Investors' procedures were deficient.

The Commission's Order imposes upon the Respondents suspensions of varying duration and extent. (Rel. 34-33298)

SELF-REGULATORY ORGANIZATIONS

UNLISTED TRADING PRIVILEGES AND WITHDRAWALS SOUGHT

Notices have been issued giving interested persons until January 3, 1994 to comment on the two applications of the Chicago Stock Exchange. Each application is for unlisted trading privileges in one over-the-counter issue and an application to withdraw unlisted trading privileges in one over-the-counter issue. (Rel. 34-33320; 34-33321)

APPROVAL OF PROPOSED RULE CHANGES

The Commission approved a proposed rule change filed by the National Association of Securities Dealers (SR-NASD-91-5) to amend Schedule I to the NASD By-Laws, which governs trading in securities designated as PORTAL securities and the operation of the computer and communications system that supports such trading. Publication of the order is expected in the Federal Register during the week of December 20. (Rel. 34-33326; International Series Rel. 622)

The Commission approved a proposed rule change filed by The Depository Trust Company (SR-DTC-90-06) relating to the eligibility of Rule 144A Securities at DTC. Publication of the order is expected in the Federal Register during the week of December 20. (Rel. 34-33327)

ACCELERATED APPROVAL OF PROPOSED RULE CHANGE

The Commission granted accelerated approval to a proposed rule change filed by the American Stock Exchange (SR-AMEX-93-35) relating to Equity Linked Term Notes. Publication of the order is expected in the Federal Register during the week of December 20. (Rel. 34-33328)
