## COMMISSION ANNOUNCEMENTS

---

### SEATTLE OFFICE TO CONDUCT 23RD NORTHWEST STATE-FEDERAL-PROVINCIAL SECURITIES CONFERENCE IN VANCOUVER, BC, ON MARCH 8

The Seattle Regional Office is conducting its 23rd Annual Northwest State-Federal-Provincial Securities Conference in Vancouver, British Columbia on March 8, 1990. This is the longest running of all the regional conferences. The principal theme will be penny stock fraud, and representatives of state, federal, provincial, and self-regulatory agencies will participate to foster cooperation and information sharing.

This conference is in conjunction with a two-day open seminar by the Northwest Securities Institute, whose sponsors include the securities and business sections of the Bar Associations of Washington, Oregon, and British Columbia. That program begins Friday, March 9, 1990, and will cover a wide range of topical regulatory and enforcement matters. Commissioner Mary L. Schapiro will address the conference.

Due to the composition of the attendees, this coordinated program alternates annually between Portland, Oregon, Seattle, Washington, and Vancouver, British Columbia. Next year's program will be held in Seattle.

## CIVIL PROCEEDINGS

---

### GERALD ROGERS AND OTHERS TEMPORARILY RESTRAINED

The Chicago Regional Office announced that on January 26, Judge Dickran Tevzorian, of the Central District of California, entered a Temporary Restraining Order against Eurobond Exchange Ltd., a/k/a Eurogold and Bond Exchange Ltd., a/k/a EBX Trust A.G. (Eurobond), Gerald Rogers a/k/a J.K. Glenn (Rogers) and Tamara Rogers (T. Rogers). The Order freezes all of the assets of the defendants and requires them to provide an accounting to the Court.

The Commission's Complaint alleges that the defendants offered and sold unregistered Eurobond securities in the form of investment contracts involving leveraged treasury bonds, thereby raising over one million dollars. The Complaint further alleges that the Defendants made material misrepresentations and omissions concerning, among other things, the risk associated with the investment and Roger's previous criminal conviction and SEC injunction. The Court set a hearing for a preliminary injunction for February 5. [SEC v. Eurobond Exchange Ltd., a/k/a Eurogold and Bond Exchange Ltd., a/k/a EBX Trust A.G., Gerald Rogers a/k/a J.K. Glenn and Tamara Rogers (C.D. Calif., Civil Action File No. CV90-378DT (GHKX)]. (LR-12364)

### NOTICE OF PROPOSED RULE CHANGE

Proposed rule changes have been filed under Rule 19b-4 by: the Depository Trust Company (SR-DTC-89-22) relating to access to the Mutual Fund Settlement, Entry and Registration Verification Service (Fund/SERV) and to the proposed fee schedule to be charged for this service (Rel. 34-27644); and Pacific Stock Exchange (SR-PSE-90-01) to delete Section 10(a) of Exchange Rule IX, entitled "Transaction Charges," which is already contained in a separate publication, "PSE Schedule of Rates and Fees." Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
