## INVESTMENT COMPANY ACT RELEASES

---

### MIDLAND FUNDING CORPORATION I

A conditional order has been issued under Section 6(c) of the Investment Company Act on an application filed by Midland Funding Corporation I and Midland Funding Corporation II. The order exempts applicants from all provisions of the Act to the extent necessary to permit applicants to assist in the financing and refinancing of certain property through leveraged lease transactions in which Midland Corporation Venture Limited Partnership will be the lessee. (Rel. IC-17678, August 16)

### STANDISH, AYER & WOOD INVESTMENT TRUST

A conditional order has been issued under Section 17(b) of the Investment Company Act on an application filed by Standish, Ayer and Wood Investment Trust (Trust) (on behalf of Standish Small Capitalization Equity Fund (Fund), a separate series of the Trust), Standish Small Equity Fund Limited Partnership (Partnership), and Standish, Ayer & Wood, Inc. The order grants an exemption from the provisions of Section 17(a) to the extent necessary to permit a proposed reorganization between the Partnership and the Fund, whereby the Partnership will transfer its assets and liabilities to the Fund in exchange for Shares. Following the reorganization, the partners of the Partnership will constitute all of the shareholders of the Fund. (Rel. IC-17679, August 16)

THOMSON MCKINNON INVESTMENT TRUST

A conditional order has been issued under Section 6(c) of the Investment Company Act on an application filed by Thomson McKinnon Investment Trust, Thomson McKinnon Assets Management L.P., and Thomson McKinnon Fund Distributors Inc. The order exempts applicants from Sections 18(f), 18(g), and 18(i) of the Act to the extent necessary to permit the Trust to sell two classes of securities representing interests in the same investment portfolio, which classes would be identical in all respects except for differences relating to class designations, distribution expenses, voting rights, and dividend payments. ## ACQUISITION OF SECURITIES

Companies and individuals must report to the Commission within ten days on Schedule 13D if after the acquisition of equity securities of a public company their beneficial interest therein exceeds five percent. Persons eligible to use the short form (Schedule 13G) may in lieu of filing a Schedule 13D file a Schedule 13G within 45 days after the end of the calendar year in which the person became subject to Section 13(d)(1). Companies and individuals making a tender offer must have on file at the time the tender offer commences a Schedule 14D-1.
