## INVESTMENT COMPANY ACT RELEASES

### ADVANTUS CAPITAL MANAGEMENT, INC., ET AL.

An order has been issued on an application filed by Advantus Capital Management, Inc. and Advantus Series Fund, Inc. under Section 6(c) of the Investment Company Act for an exemption from Section 15(a) of the Act, Rule 18f-2 under the Act, and certain disclosure requirements under the Act. The order permits applicants to enter into and materially amend investment management agreements with subadvisers without obtaining shareholder approval, and grants relief from certain disclosure requirements regarding advisory fees paid to the subadvisers.
