### SEC CHARGES BROKER WITH STEALING INVESTOR FUNDS

On November 4, the Commission filed an emergency action to halt the fraudulent activities of Peter Joseph Cammarano, a former licensed securities salesman who, the Commission charges, misappropriated up to \$1.5 million of investor funds, including retirement funds, from investors in the Houston, Texas area. Judge Sim Lake, federal district judge for the Southern District of Texas, granted the Commission's request and entered a temporary restraining order and asset freeze against Cammarano and Cammarano and Associates, Inc. (CAI), an unregistered brokerage business owned by Cammarano.

The Commission's complaint alleges that Cammarano solicited clients to liquidate or transfer their retirement money and other investments to a CAI business account for the stated purpose of purchasing securities and other investments in those accounts. Cammarano provided his customers with confirmations and account statements on CAI letterhead, reflecting that securities or other investments had purportedly been purchased for the customers' account; however, contrary to Cammarano's representations to his clients, Cammarano deposited the clients' funds into bank accounts that he controlled. According to the complaint, Cammarano recently misrepresented to an elderly woman that her \$125,000 transfer of retirement funds into a CAI business account would be used to invest in shares of Exxon and money market instruments, and solicited \$100,000 from another elderly customer for the intended purpose of purchasing money market instruments. In fact, neither of these investments were ever made.

The Commission seeks a Court order permanently enjoining Cammarano and CAI from engaging in further violations of Section 17(a) of the Securities Act of 1933, and Section 10(b) and 15(a)(1) of the Securities Exchange Act of 1934, and Rule 10b-5 thereunder. The Commission also seeks a sworn accounting of all investor funds or assets received by Cammarano and CAI, disgorgement of all wrongfully obtained profits, and a payment of civil penalties. [SEC v. **PERMANENT INJUNCTION, OFFICER AND DIRECTOR BAR, DISGORGEMENT AND CIVIL PENALTY ORDERED AGAINST GERARD BURNS**

The Commission announced that on October 21, 1998 the United States District Court for the Southern District of Florida entered a final judgment of permanent injunction (Final Judgment) and other equitable relief against Gerard Burns (Burns), former president of VDS Enterprises, Inc. (VDS), a publicly traded company in the environmental clean-up business. The Commission had filed its suit on September 29, 1997, seeking, as against Burns, injunctive and other equitable relief, including disgorgement, civil penalties and an officer and director bar.

The Final Judgment enjoins Burns from future violations of the antifraud provisions of the Securities Act of 1933 and the Securities Exchange Act of 1934 (Exchange Act), and enjoins Burns, when acting as a control person, from causing violations of the recordkeeping provisions of the Exchange Act, from making or causing to be made false statements to auditors, and from filing or causing to be filed with the Commission false reports. In addition, the Final Judgment permanently bars Burns from acting as an officer or director of any public issuer, and orders Burns to pay a \$100,000 civil penalty, disgorgement in the amount of \$2,700,000, and prejudgment interest in the amount of \$1,063,960. **AMERICAN FIDELITY ASSURANCE COMPANY, ET AL.**

An order has been issued pursuant to Section 17(b) of the Investment Company Act to American Fidelity Assurance Company, American Fidelity Variable Annuity Fund A (Account A), and American Fidelity Dual Strategy Fund, Inc. (Dual Strategy Fund) (collectively, the Applicants) exempting the Applicants from the provisions of Section 17(a) of the Act, to the extent necessary to permit the transfer of securities and other instruments held by Account A to the Dual Strategy Fund in exchange for shares of the Dual Strategy Fund in connection with the reorganization of Account A that will change Account A from a management investment company to a unit investment trust. (Rel. IC-23523 - November 4)

**PROVIDENT MUTUAL LIFE INSURANCE COMPANY, ET AL.**

A notice has been issued giving interested persons until November 30 to request a hearing on an application filed by Provident Mutual Life Insurance Company (PMLIC), Providentmutual Life and Annuity Company of America (PLACA), Provident Mutual Variable Managed

Separate Account (Managed Account), Provident Mutual Variable Separate Account (Separate Account), Provident Mutual Variable Annuity Separate Account (Variable Account) and Provident Mutual Variable Life Separate Account (Variable Life Account) (collectively, Applicants). The Applicants seek an order pursuant to Section 26(b) of the Investment Company Act approving the substitution of securities issued by certain management investment companies and held by either the Managed Account, the Separate Account, the Variable Account or the Variable Life Account to support variable life insurance contracts or variable annuity contracts issued by PMLIC or PLACA. Applicants also seek an order pursuant to Section 17(b) of the Act exempting them from Section 17(a) of the Act to the extent necessary to permit PMLIC to consolidate the Managed Account with the Separate Account and to permit PLACA to consolidate two subaccounts of the Variable Account and to consolidate two subaccounts of the Variable Life Account. #### **SCUDDER GLOBAL FUND, INC., ET AL.**

An order has been issued on an application filed by Scudder Global Fund, Inc., et al. under Section 17(d) of the Investment Company Act and Rule 17d-1 under the Act. The order permits certain registered management investment companies to deposit their uninvested cash balances in joint accounts investing in short-term repurchase agreements. (Rel. #### **GPU, INC.**

An order has been issued authorizing GPU, Inc., a registered holding company, to distribute rights regarding its common stock under a stockholder rights plan. (Rel. 35-26937)

#### **SELF-REGULATORY ORGANIZATIONS**

#### **PROPOSED RULE CHANGES**

The New York Stock Exchange filed a proposed rule change (SR-NYSE-98-33) under Rule 19b-4 of the Securities Exchange Act of 1934 amending NYSE Rule 64 to permit non-regular way trades that are less than 4/16 point away from the regular way bid or offer to be conducted without Floor Official approval. Publication of the notice is expected in the Federal Register during the week of November 9. (Rel. 34-40631)

The National Securities Clearing Corporation filed a proposed rule change (SR-NSCC-98-13) under Section 19(b)(3)(A) of the Act. The

proposed rule change, which became effective upon filing, modifies NSCC's Annuities Processing Service to permit members to submit data and settle payments with respect to life insurance products. Publication of the proposal is expected in the Federal Register during the week of November 9. (Rel. 34-40634)

The Options Clearing Corporation filed a proposed rule change (SR-OCC-98-09) under Section 19(b)(1) of the Exchange Act. Under the proposed rule change, OCC will amend its By-Laws and Rules to provide for the clearance and settlement of differential index options. Publication of the proposal is expected in the Federal Register during the week of November 9. (Rel. 34-40638)

#### APPROVAL OF PROPOSED RULE CHANGE

The Commission has approved a proposed rule change filed by the Government Securities Clearing Corporation (SR-GSCC-98-03) under Section 19(b)(2) of the Exchange Act. The rule change amends GSCC's by-laws to allow GSCC's Board of Directors to determine which individuals shall serve as chief executive officer and chief operating officer. (Rel. 34-40635)
