Alaska Housing Finance Corporation-HOMEOWNERSHIP AT WORK

Alaska keeps it simple. Their Housing Choice Voucher (HCV) Homeownership Program was approved by the Alaska Housing Finance Corporation (AHFC) Board of Directors in July of 2003. By December of 2003, Ms. Antonia Fandycz of North Pole, Alaska became the program's first homeowner.

All potential participants complete a one-page, "Are your Ducks in a Row for HCV Homeownership" form. If eligible, a one-page Certification of Eligibility is issued which provides an estimated amount of HAP to use for loan origination. The lender determines mortgage-readiness and loan products. AHFC's Homeownership Administrator works closely with the lender during the loan origination process. A re-exam is completed after the participant has secured loan commitment and prior to closing. A Certificate of Housing Assistance Payment is then issued which specifies the amount and the term of housing assistance. A yearly Servicing Agreement is drafted between AHFC and the participant that sets forth disbursement of the HAP. Homeownership obligations are reviewed yearly and contact is maintained throughout the year with participants. Two sessions of post-purchase counseling are required.

Alaska's program partners are essential to the program's success. AHFC's Mortgage Department provides first-time homebuyer loan products and the first eight-hour session of housing counseling, along with local community housing development corporations. Lenders often access *Home\$tart* or *Home\$tart Plus* programs. Other down payment assistance opportunities are provided by the Municipality of Anchorage AnCHOR program, the Alaska Mental Health Trust Authority, and in rural areas, USDA provides access to their leveraged loan program products. Utilization of existing rental voucher program staff is another key ingredient for Alaska's homeownership program. Field staff complete the income re-exams, HQS inspections, and provide ongoing information to voucher participants with regard to the availability of the program.

To date, a total of fourteen families have become homeowners under the HCV Homeownership program with several additional mortgage-ready participants awaiting down payment assistance. AHFC plans to expand the program to non-disabled voucher participants during the next year. **Thanks to AHFC for this submission.**

2005 SuperNOFA Published

The U.S. Department of Housing and Urban Development has consolidated most of its grant programs into one Super Notice of Funding Availability. The fiscal year 2005 SuperNOFA announces the availability of approximately \$2.26 billion in HUD program funds covering fifty-three grant categories. Application due dates are different for each program. You must submit a completed application to HUD on or before the respective program application due date.

REMINDER: HUD now requires all applicants to submit applications electronically using http://www.grants.gov Registration is required. To register, log on to http://www.grants.gov and follow the steps.

Project-Based Section 8 HCV Forms Updated

PBA HAP contract for existing housing projects only (HUD-52530B (9/01)) was revised to incorporate the new PBA law changes and the initial implementing guidance issued in the January 16, 2001 Federal Register notice. (Note: form not in HUDCLIPS - obtain copy from local field office).

PBA HAP contract for **new construction and rehabilitation** projects only (HUD-52530A (6/01)) was revised to incorporate the new PBA law changes and the initial implementing guidance issued in the January 16, 2001 Federal Register notice. (Note: form not in HUDCLIPS – obtain copy from local field office).

PHAs providing PBA for rehabilitation or new construction projects should continue to use the PBA Agreement to Enter into Housing Assistance Payments (AHAP) Contract (HUD-52531A (4/90) and HUD-52531B (12/88)). (Note: form available in HUDCLIPS). (PHAs providing PBA for existing housing are not required to enter an AHAP).

PHAs providing PBA should continue to use the PBA lease addendum (HUD-52530 C (5/89) (as of 02/26/2002, and the PBA Statement of Family Responsibility (HUD-52578 B (1/96). (Note: forms not in HUDCLIPS – obtain copy from local field office).
