- a. Public Affairs Office
- (1) Serve as overall coordinator for ceremony execution, preparations and rehearsals.
- (2) Publish LOI.

- (4) Arrange for preparation, printing and mailing of invitations.
- (5) Prepare, print and distribute programs.
- (6) Contact appropriate media.
- (7) Prepare and place name cards in reserved seating.
- (8) Provide instructions to ushers.
- (9) Coordinate staging decorations and bunting.
- (10) Coordinate audio-visual and public address support.
- (11) Prepare brief remarks as requested.

c. The ceremony will be conducted in accordance with Annex A.

d. DDE will be prepared to brief MG Arnold and COL Rowan on their roles in the ceremony prior to the event.

e. Staging, tents, podiums, decorations, flags and public address system will be in place prior to 0730, 12 July.

The following is a sequence of events:

0900-1000	Parking and seating.
0940-1000	Pre-ceremony music by JPAS.
0945	All participants arrive at the Front Entrance.
0945	Color Guard forms location at the Front Entrance.
1000	LTC Burt takes position at the podium on main stage, welcomes the audience and states, "Ladies & Gentlemen, please rise for the official party, and remain standing for the presentation of the Colors, our <i>National Anthem</i> and the Invocation."
1000	Official party enters and takes its place in front of the chairs. Band plays Ruffles and Flourishes and The General's March.

	LTC Burt introduces Gary Hawkins for the Invocation.
	LTC Burt requests the audience be seated.

LTC Burt explains the Change of Command Ceremony.

MG Arnold, COL Julich and COL Rowan move to center stage.

Simultaneously, Mr. John Saia removes the Engineers Colors from its stand. MG Arnold steps to the center, COL Julich steps up and faces left: COL Rowan moves directly to a position at MG Arnold's left, facing COL Julich; while Mr. Saia moves to a position at the left of COL Rowan, facing MG Arnold and completing the diamond.

LTC Burt reads the Assumption of Command Order.

Mr. Saia passes the Corps flag to COL Julich.

COL Julich passes the flag to MG Arnold.

MG Arnold passes the flag to COL Rowan.

COL Rowan passes the flag to Mr. Saia.

Mr. Saia returns the flag to its stand and returns to his seat. COL Rowan returns to sit, assuming COL Julich's seat. COL Julich returns to COL Rowan's seat. MG Arnold remains to make remarks.

Color Guard moves forward, salutes and asks COL Rowan for permission to retire the Colors. COL Rowan salutes and replies: "Permission granted."

LTC Burt states, "This concludes the ceremony. All guests and employees are invited to join MG Arnold and COL and Mrs. Rowan in the receiving line and reception in the district assembly room."

Band plays post-ceremony music.
