## **NRC SEEKS PUBLIC INPUT ON ENVIRONMENTAL SCOPING FOR PSEG EARLY SITE PERMIT; MEETINGS SCHEDULED NOV. 4**

Nuclear Regulatory Commission staff will conduct public meetings in Carneys Point, N.J., on Thursday, Nov. 4, to discuss the agency's review of an Early Site Permit (ESP) application from PSEG for a site near Salem, N.J., and the environmental issues the agency should consider in reviewing the application.

The NRC will hold the meetings in the theater at Davidow Hall on the Salem Community College campus, 460 Hollywood Ave. in Carneys Point, from 1-4 p.m. and 7-10 p.m. Parking will only be available in Lot "A" on campus. NRC staff presentations will describe the ESP process, focusing on the environmental review, followed by a public comment period. The NRC will host open houses from noon to 1 p.m. and 6-7 p.m. so members of the public have the opportunity to talk informally with agency staff.

PSEG submitted its ESP application, including an environmental report, on May 25. The environmental report is available via the NRC's electronic document database, ADAMS, by entering accession number ML101480763 in the ADAMS search engine at: <http://adamspublic.nrc.gov/fnopenclint/>. In addition, the Penns Grove-Carneys Point Public Library at 222 South Broad St. in Penns Grove; the Pennsville Public Library at 190 S. Broadway in Pennsville, N.J.; and the Salem Free Public Library at 112 W. Broadway in Salem, N.J., have all agreed to maintain a copy of the environmental report for public inspection.

Those wishing to speak may also register at each meeting no later than 12:45 p.m. and 6:45 p.m., respectively. Individual comments could be limited by the time available and the number of people wishing to speak.

NRC staff will also consider written comments on environmental issues until Dec. 14, following the publication of a notice in the *Federal Register* (<http://edocket.access.gpo.gov/2010/pdf/2010-25998.pdf>). In the near future the NRC will publish in the *Federal Register* a notice of opportunity to intervene in the required adjudicatory hearing. Petitions to intervene in a hearing must be filed within 60 days of the notice, by anyone whose interest may be affected by the proposed permit and who wishes to participate as a party in the proceeding. An NRC decision to issue an ESP means the site is suitable for a nuclear power facility, contingent on the approval of an additional application for a construction permit or combined license. An ESP is valid for 10 to 20 years and can potentially be renewed for an additional 10 to 20 years.
