Dear Mr. Lake:

In response to the ex parte filing submitted earlier today on behalf of the American Cable Association ("ACA") raising issues about the accessibility of the data Comcast produced in response to the Commission's Information and Discovery Request, 1 Comcast has provided ACA's Authorized Representatives with the native Excel files that Comcast produced to the Commission on Friday, June 11, and that ACA received in PDF format on June 15.2 Therefore, there is no need for Commission action on this issue.

This result is consistent with Comcast's accommodation of another party in this proceeding through direct and informal communications with that party.³ Comcast is willing to provide this data in its native format to any other authorized party that requests it from Comcast's outside counsel.⁴
