To suspend temporarily the duty on Direct Green 91.

1	Be it enacted by the Senate and House of Representa-					
2	tives of the United States of America in Congress assembled,					
3	SECTION 1. DIRECT GREEN 91.					
4	(a) In General.—Subchapter II of chapter 99 of					
5	the Harmonized Tariff Schedule of the United States is					
6	amended by inserting in numerical sequence the following					
7	new heading:

diazenediyl)]bis[4-amino-5hydroxy-6-(2-phenyldiazenyl)-, sodium salt (1:4)) (CAS No. 59262-64-5) (provided for in subheading 3204.14.50)

- 3 from warehouse for consumption, on or after the 15th day

4 after the date of the enactment of this Act.
