The subject product is a mixture of two synthetic dyes and is used in the textile industry. It is imported from India.

The article description was modified to correct the name of the second component of the mixture and to fit the format used in the Chapter 99 provisions, and to reflect the correct HTS subheading reference.

According to an e-mail from a National Import Specialist at U.S. Customs and Border Patrol (dated May 9, 2012), the mixture should be classified in HTS subheading 3204.11.50.

#### VI. Continuation

If enacted, the tariff relief provided for in this bill would be available to any entity that imports the product that is covered by the bill.
