3 **SECTION 1. 4-(2,4-DICHLOROPHENOXY) BUTYRIC ACID AND**
4 **4-(2,4-DICHLOROPHENOXY) BUTYRIC ACID, DI-**
5 **METHYLAMINE SALT.**

6 (a) IN GENERAL.—Heading 9902.23.26 of the Har-
7 monized Tariff Schedule of the United States (relating to
8 4-(2,4-dichlorophenoxy) butyric acid and 4-(2,4-
9 dichlorophenoxy) butyric acid, dimethylamine salt) is

1 amended by striking the date in the effective period col-
2 umn and inserting “12/31/2015”.

3 (b) **EFFECTIVE DATE.**—The amendment made by
4 subsection (a) applies with respect to goods entered, or
5 withdrawn from warehouse for consumption, on or after
6 the 15th day after the date of enactment of this Act.
