A BILL

To extend the temporary suspension of duty on Benzene, 2,4-dichloro-1,3-dinitro-5-(trifluoromethyl).

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. BENZENE, 2,4-DICHLORO-1,3-DINITRO-5-
- 4 (TRIFLUOROMETHYL).
- 5 (a) In General.—Heading 9902.40.56 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 Benzene, 2,4-dichloro-1,3-dinitro-5-(trifluoromethyl)) is
- 8 amended by striking "12/31/2012" and inserting "12/31/2012"
- 9 2015".

- 1 (b) Effective Date.—The amendments made by
- 2 subsection (a) apply with respect to goods entered, or
- 3 withdrawn from warehouse for consumption, on or after

4 the 15th day after the date of enactment of this Act.
