To extend the temporary suspension of duty on Cyprodinil.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. CYPRODINIL.

4 (a) IN GENERAL.—Heading 9902.02.08 of the Har5 monized Tariff Schedule of the United States (relating to
6 Cyprodinil) is amended by striking "12/31/2012" and in7 serting "12/31/2015".

8 (b) EFFECTIVE DATE.—The amendments made by 9 subsection (a) apply with respect to goods entered, or 10 withdrawn from warehouse for consumption, on or after 11 the 15th day after the date of enactment of this Act.
