- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. 4-CHLORO-3,5-DINITRO- $\alpha,\alpha,\alpha$ -
- 4 TRIFLUOROTOLUENE.
- 5 (a) In General.—Heading 9902.40.83 of the Har-
- 6 monized Tariff Schedule of the United States (relating to
- 7 4-Chloro-3,5-dinitro- $\alpha,\alpha,\alpha$ -trifluorotoluene) is amended
- 8 by striking "12/31/2012" and inserting "12/31/2015".
- 9 (b) Effective Date.—The amendments made by
- 10 subsection (a) apply with respect to goods entered, or

- 1 withdrawn from warehouse for consumption, on or after
- 2 the 15th day after the date of enactment of this Act.
