The bill is intended to cover formulated herbicides containing methyl 2-[(4-methyl-5-oxo-3-propoxy-4,5-dihydro-[1,2,4] triazole-1-carbonyl)sulfamoyl]benzoate, sodium salt (Propoxycarbazone-sodium) and therefore must be expressed in a broader form than the wording used in the bill as introduced.
