III. Other product information, including uses/applications and source(s) of imports

The subject product is an agricultural chemical, insecticide, used for insect control on crops including: corn, cotton, curbits, potatoes, and sunflowers. The subject product is imported from Vietnam and China and formulated into agricultural insecticide application products that are not sold domestically but produced only for export.

The interested entity states that the actual Customs revenue loss in each year during 2013-17 would be \$0 because the interested entity currently avoids all tariff costs on its imports of the subject product (Carbofuran technical) through the duty drawback process by exporting all formulations of this product. However, other parties might be importing the subject product for domestic use.
