A BILL

To suspend temporarily the duty on Oxalic acid, diethyl ester (DEO).

1	Be it enacted by the Senate and House of Representa-
2	tives of the United States of America in Congress assembled,
3	SECTION 1. OXALIC ACID, DIETHYL ESTER (DEO).
4	(a) In General.—Subchapter II of chapter 99 of
5	the Harmonized Tariff Schedule of the United States is
6	amended by inserting in numerical sequence the following
